On August 16, 2022, a Single Justice of the Maine Supreme Judicial Court entered an order on Kinley MacDonald's complaint in docket number SJC-22-

4. On October 7, 2022, MacDonald filed a notice of appeal. The Clerk of the Law Court docketed the appeal under Law Court docket number Cum-22-327.

The notice of appeal was filed 52 days after the entry of the order appealed from and is therefore untimely. *See* M.R. App. P. 2B(c)(1) (requiring an appeal to be commenced within 21 days after entry into the docket of the judgment or order appealed from).

It is therefore ORDERED that MacDonald's appeal is DISMISSED as untimely.


Kinley Macdonald, aka Mary Johnson and other aliases ("Macdonald"), has filed a Motion to Dismiss/Remove Judge in which she repeats a long list of grievances that she previously presented to the Executive Clerk of the Supreme Judicial Court. In a twenty-two-page opinion, Associate Justice Horton of the Supreme Judicial Court comprehensively considered and rejected Macdonald's grievances. *MacDonald v. Lambrew, et. al., Order Dismissing Complaint* (August 15, 2022). As explained by Justice Horton, this Court has provided Macdonald with more than adequate due process. Moreover, as determined by Justice Horton, "[e]ven if MacDonald did have the legal right to custody of her children, the Court would exercise its discretion to decline to return custody of the children to her." *Id.* at \*13. According to Justice Horton: "The facts as stated in the documents that MacDonald provides shows that MacDonald's untreated mental health conditions prevent her from adequately caring for her children." *Id.* at \*14. A copy of Justice Horton's opinion is attached for

convenience to this Order.<sup>1</sup> For all of the foregoing reasons, Macdonald's Motion to Dismiss/Remove Judge is DENIED.
