APPLICATION FOR A WRIT OF CERTIORARI

COMES NOW, Marcrease Delance Farmer (Hereinafter "Farmer"), (Pro se') petitioner representing himself, absent of counsel, before this Honorable Court, seeking a "Rehearing" before this Court and the lower Courts as to a denial for a Writ of Certiorari as to his Motion pursuant to "With Held" trial Information.

Farmer, presents his motion before this Court without representing of "LEGAL COUNSEL" and asks this Honorable Court to refer to him as "Farmer", Farmer states under penalty of perjury he is acting "Pro se'", is without Legal Counsel and seeks the Courts review to its recent denial of his motion as to a "Writ of Certiorari, pursuant to Rule 12.2 of the Rulebook also see, Rule 29.5(b) a "Rehearing" for application of a request for a writ of Certiorari", see Haines v. Kerner, 404 U.S. 519 (1972), Where he is a layman pro se' petitioner, therefore, he would respectfully ask that this Court review the Motion for Rehearing and Plea in Absentia, with less stringent standards than pleading

drafted by professionals pursuant to Estelle v. Gamble, 429 U.S. 106 (1976).

### JURISDICTION

This Court holds all jurisdiction for review for a motion concerning a request for a "Rehearing". This Court issued a denial to request for a "Writ of Certiorari" on Oct. 2, 2023, pursuant to whether withheld evidence trigger's new trial, by granting this motion Farmer contains an introduction stating that (1) a material factual or legal matter was overlooked; (2) a change in law occurred after submission of the case and was overlooked; (3) the opinion conflicts with the Supreme Court, this Court, or another court of appeals, and the conflict was not addressed; or (4) the case involves one or more questions of exceptional importance. see Smith v. Phillips, 455 U.S. 209, 71 L.Ed.2d 78, 102 S. Ct. 940 (1981); United States v. Glover, 681 F.3d, 411, 401 U.S. App. D.C. 80 (D.C. Cir. 2012); United States v. Canoon, 23 F4th 636, 2022 FED. App 4p. 117 Fed.R.Evid.Serv(CBC) 695(6th Cir.)cert denied 142 S. Ct. 283, 211 L.Ed.2d 132 (2021).

### ABUSE OF DISCRETION

A review of the lower Court judgment for abuse of discretion has three essential components:

- 1) Was the Court's judgment under the courts discretion has authorized by law?
- 2) Did the district court understand its own discretion and, if so, did the district court provide its honest Service by exercising its sound discretion?
- 3) Did the district court exercise its discretion?

## ARGUMENT

- (A) DISTRICT COURT ABUSED ITS DISCRETION IN FAILING TO ACT BY DISMISSING JUROR WHO, DURING VOIR DIRE, SUDDENLY REALIZED THAT SHE KNEW DEFENDANT'S SISTER - POTENTIAL IMPLIED BIAS

Whether the withheld information may trigger new trial. In Farmer's original Writ of Certiorari, Farmer questioned the Court as to whether or not his right to fair trial was violated due to his counsel of record withholding information from Farmer and the Courts regarding the conflict of interest between Juror No# 11 (Eleven)<sup>3</sup> and Farmer's sister, "Jahvashea Farmer" (where both had prior altercation which could possibly result by retaliation or reward which is conflict) due to Juror No. 11's son's involvement with property damage belonging to Farmer's Sister, and pursuant to her police report.

By withholding the information of Farmer's Sister and Juror No. #11's conflict, resulted in (1) material factual or legal matter was overlooked, (2) the case involves one or more question of acceptional importance. (3) Was not present for the sidebar meeting when Juror No.11 admitted toknowing Farmer's (4) Counsel of Record making no objections after Juror No. 11 admitted knowing a family member of Farmer and being questioned about it by the Court and because counsel of record failed to object and/or make any challenges, resulted in being DENIED any conflict of interest and/or biased Juror claims after losing at trial; and (5) without any objections allowed Juror No. 11 to perjure herself and fabricate answers to satisfy the Court.

Juror 11's perjured answers including one fabricated fact that the court failed to recognize and act within their bounds of discretion in dismissing juror #11 and substituting her with one

of the alternatives: Juror #11 [also know as VP27] Stated:

"As we went to the bathroom [during a court recess],  
I had noticed the family members are out there and  
I do know - if those are his family members, I do  
I do know them, they are from Malden area, Me and My  
Husband served as foster parents and we have our kids  
that stay the night over at this woman's house that's  
outside ...."

See; Trial Transcripts Page 67.

As soon as the woman admitted to a continued interaction between their families, the more the Court failed to act within its power of discretion and dismiss juror No.11 and substitute her with one of the alternatives due to a potential for implied bias caused by a connection between juror and her family, and Farmer's family. see United States v. Glover, 681 F.3d 411, 401 U.S. App. D.C. 80 (D.C. Cir. 2012)("where the district court acted immediately well within bounds of its authority in dismissing juror, who during trial, suddenly realized that she knew defendant's wife. because her daughter went to school with defendant's wife"). see also, United States v. Cannon, 987 F.3d 924, 947; Cunningham v. Shoop, 23 F4th 636, 2022 FED. App. 4p., 117 Fed.R.Evid.Serv.(CBC) 695 (6th Cir.)cert. denied 142 S. Ct. 283, 211 L.Ed.2d 132 (2021)

In Smith v. Phillippe, 455 U.S. 209, 215, 71 L.Ed.2d 78, 102 S. Ct. 940 (1981), this Court examined cases of implied or inferable juror bias. Juror No.11, was asked repeatedly is she would feel uncomfortable in making a decision to convict Farmer in which she replied, "I will". "I would". "Yes, I would". see; Trans. P. 71, L. 17-24. Paul Hahn, U.S. Atty., asked again, "Okay, that's what we are trying to get at". In which she replied, "Yess, I would". Id. P. 71. l. 25 and P. 72 L. 1-2. Hahn then asked, "would you feel uncomfortable sitting in this case?" "I would", was her reply. Id. P. 73 L. 3-5.

If there was no "connection" between her [Juror 11] and Farmer's Family [sister], why would Juror 11, "Feel uncomfortable?" If Juror 11's kids were staying at Farmer's family's house, why would Juror 11 "feel uncomfortable? with the alleged continued interaction between Juror 11's kids staying at Farmer's Family's house, and Juror 11 having concerns of "Feeling uncomfortable", the Court abused its discretion for not acting on dismissing Juror 11, When the potential for implied bias counseled in favor of dismissing Juror 11 and substituting her with one of the alternative.

(B) WAS COUNSEL'S STRATEGIC DECISION AND ACTUAL NOTICE IMPROPER BY WITH HOLDING JUROR BIAS INFORMATION FROM FARMER A VIOLA OF DUE PROCESS AND RIGHT TO A FAIR TRIAL AND/OR RECLUDE FARMER DUE PROCESS AND A FAIR TRIAL.

The Fourteenth Amendment to the Constitution of the United States, Which provides:

All person born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of life, liberty, or property without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

Previously, Farmer questioned this Court as to him exercising his right to trial and during vior dire Counsel withheld critical juror bias information from him and the Courts, does this violate Due Process and the right to a "new and fair Trial?" The record is quite clear and evident that counsel's strategic decision was

to have juror 11 on the jury panel due to the fact that she was the only "black" juror during the entire jury selection, as if the "race card" played a role in the sight of justice.

However, during the court recess, Counsel learned "Then", that from Farmer's sister, ~~there was prior altercation~~ involving Farmer's sister and the woman identified as 'Juror No. 11', Which involved Juror 11's son damaging Farmer's sister's property, which also lead to the pressing of charges that involved the police department and a investigation was provided.

After the recess, a side bar was held because during recess Juror No. 11, Then" recognized Farmer's relatives as mention earlier to counsel of record. And not only was Farmer unaware of the interaction between his family members and of the previous and present interaction with Juror No. 11 and her son, involving a prior altercation, but Farmer was not allowed to be present at the side bar.

Therefore, Farmer's lack of knowledge of his sister's previous altercation with Juror #11, and the possibility that there could have posibly been some sort of retaliation had Juror #11, recognized Farmer as being related to the woman that filed police report on her son for property damage cause for a rehearing to settle the conflict between Juror #11 and whether there was conflict of interest by allowing her to stay as Juror after facts presented itself during recess?

To obtain a new trial based on juror bias, Farmer must prove "Three prongs: (1) that juror answered dishonestly, not just inaccurately; (2) that Juror was motivated by partiality; (3) That the true facts, if known, would have supported striking juror for cause." see; United States v. Tucker, 137,F.3d at, 1026(1997);

also United States v. Williams, 79 F.3d 1098, 1100 (8th Cir. 1996 ), cert. denied, 519 U.S. 967, 117 S. Ct. 392, 136 L.Ed.2d 308.

NOTE: Juror No.11, was asked, "Is there anything that may cause you to hesitate is free of outside influences ... that may affect your verdict one? Her reply was, "RIGHT". see Trial Trans P. 72, L.-1, L-8.

The Court knew of the strategic plan to have juror #11, on the panel because she was African American, thereby, allowing the facts of "Color" stand as Justice while the conflict of interest still linger as to construe juror#11 as being the only "Black Juror" on the panel.

When Farmer filed for "New trial" based on juror bias, the Court concluded that Farmer purposely left Juror #11 on the panel gambling on a favorable verdict "due to race" card, by remaining silent about previous altercations, during the voir dire without any questions and/or objections to the facts informed to Counsel of record by Farmer's sister. see R.Doc. 128 at 17. It was not Farmer who was "gambling", it was his counsel. see Sixth Amendment.

The Sixth Amendment to the U.S. Constitution guarantees the rights of a person accused of a crime to the "effective assistance of counsel. see McMann v. Richardson, 379 U.S. 759, 771(1970 ) to perform reasonable competently, defense counsel must make reasonable investigations into both the law and "facts" of the case, and pursue meritorious legal issues, including at sentencing. see Strickland v. Washington, 466 U.S. 668, 690-691 (1984) where the "Strickland Standard" for evaluating claims of ineffective assistance of counsel at trial. see Hill v. Lockhart, 474 U.S. 52, 58 (1985).

Without any questions and/or objections by remaining silent, the Court relied on Juror #11's "honesty and lack of bias" when she came forward on her own, initially to express concern after Juror#11, recognized Farmer's sister outside the courtroom based on previous altercation, and that she "professed" multiple times that she could be "impartial" and "fair". see R.Doc. 128 at 17, 18

However, the district court further found that Farmer failed to allege "implied bias," emphasizing that "bias may only be implied only in certain egregious situations." Id. at 19.(citing Tucker, 243 F.3d at 509).

Once the Court heard juror #11's continued interaction between both families [Juror's and Farmer's] it was the court duty to not fail by acting on it's own discretion and to dismiss Juror #11, as bias, when the potential implied bias counseled in favor of dismissing Juror #11.

To establish prejudice where the challenge is to the course of legal representation proceeding the plea, it is also necessary to show a reasonable probability that the end result of the criminal process would have been more favorable by reason of a plea to a lesser charge or a sentence of less prison time. see Missouri v. Frye, 566 U.S. 134, 147(2012).

Counsel's own strategic decision backfired, not on Counsel, but "to" Farmer, by the withholding of critical juror bias information from Farmer precluded any due process and a right to a new and fair trial.



CLOSING

Farmer's attorney for his trial was not effective as to his Constitutional Rights as to legal due process and a fair trial, based on the withholding of important information informed to Counsel of record, but failing to properly inform Farmer of such facts that may lead to possible relief at trial. Withholding critical juror bias information from Farmer during Voir dire, is enough evidence to warrant Farmer a new trial by granting Writ of Certiorari to the U.S. Supreme Court.

Farmer now respectfully request that this Court prevent a fundamental miscarriage of justice by vacating judgment and to remand him for further proceedings, and/or a new Trial, all in the interest of Justice, in GRANTING CERTIORARI.
