
ORDER APPOINTING APPELLATE COUNSEL

Isidro Delacruz was convicted of capital murder and sentenced to death on April 17, 2018. Pursuant to TEX. CODE CRIM. PROC. Art. 37.071(h), the judgment of conviction and sentence of death are subject to automatic review by the Court of Criminal Appeals. The Court finds that Mr. Delacruz is indigent and desires to have counsel appointed to represent him in further proceedings. Under TEX. CODE CRIM. PROC. Art. 26.052(i), Mr. Delacruz is entitled to the appointment of competent counsel on appeal and for the purpose of filing a petition for writ of certiorari to the United States Supreme Court.

Hilary Sheard is an attorney licensed in the State of Texas, and is qualified for appointment for the appeal of death penalty cases in the Fourth Administrative Judicial Region. The Court hereby appoints Ms. Sheard as appellate counsel for Mr. Delacruz.

The District Clerk is hereby ordered to forward a copy of this Order to Hilary Sheard and to Deana Williamson, Clerk, Court of Criminal Appeals.
