

Ever since the ongoing problem with my employer, the Veterans Administration, began over four years ago, I have suffered from a psychological condition which has been diagnosed as posttraumatic stress disorder. It started with the feelings I had after being charged with three or four serious crimes (one which doesn't even exist as a crime in Pennsylvania) all connected with the fact that I was a person infected with HIV. I had done nothing wrong, yet it took me over a year to have the crimes disposed of and totally expunged from my record (although I still cannot get the veterans administration to remove information about my criminal arrest from my personnel record). After I returned to work following my indefinite suspension, I continued to suffer from episodes of PTSD which includes psychological distress which can be intense and disabling, with the result that I have to call off work because of the alteration in cognition and mood which makes it impossible to perform my normal work activities. Every time the authorities find against me, another episode occurs and I miss work, need to increase my psychotherapy, medication, even undergo hospitalization. I have lost, and continue to lose, wages as a result of my condition. And my medical expenses continue to be abnormally high.
