ORDER

Before: LARSEN, Circuit Judge.

Corey A. Askew, proceeding pro se, appeals the district court's judgment dismissing without prejudice his petition for a writ of habeas corpus filed under 28 U.S.C. § 2241. Askew moves for a certificate of appealability.

In October 2022, Askew filed a § 2241 petition. He sought to challenge his pretrial detention, and he identified three criminal cases that were filed against him. Askew noted that (1) he was convicted by a jury in two of the cases and that sentencing was set for January 2023 and (2) the other case was filed against him on August 31, 2022. In his petition, Askew primarily argued that the trial court lacked jurisdiction over him because he is a citizen and ambassador of the "Olmec State," rather than Michigan or the United States. Upon initial screening, the district court dismissed Askew's petition without prejudice and declined to issue a certificate of appealability, concluding that he did not properly exhaust his administrative remedies.


Askew now seeks a certificate of appealability, arguing that the district court erred by dismissing his petition. To obtain a certificate of appealability, a petitioner must make "a substantial showing of the denial of a constitutional right." 28 U.S.C. § 2253(c)(2). Where a district court has rejected a claim on procedural grounds, the petitioner must show both that jurists of reason would find the district court's procedural ruling debatable and that jurists of reason would

find it debatable whether the petition “states a valid claim of the denial of a constitutional right.” *Slack v. McDaniel*, 529 U.S. 473, 484 (2000). To show that a petition states a valid claim of the denial of a constitutional right, the petitioner must demonstrate that his claim is “arguably valid or meritorious.” *Dufresne v. Palmer*, 876 F.3d 248, 254 (6th Cir. 2017) (per curiam) (emphasis omitted). Thus, this court must make a “modest assessment of the merits of the claim” when deciding whether to issue a certificate of appealability. *Id.*

A certificate of appealability is unwarranted because Askew’s claims for relief are not arguably valid or meritorious. His contention that the trial court lacks jurisdiction over him because he is a citizen and ambassador of the “Olmec State” is similar to the arguments made by tax protesters, sovereign citizens, and Moorish-Americans that we have deemed meritless. *See United States v. Coleman*, 871 F.3d 470, 476 (6th Cir. 2017). And Askew did not otherwise set forth any potentially viable claim for relief.

Accordingly, Askew’s motion for a certificate of appealability is **DENIED**.



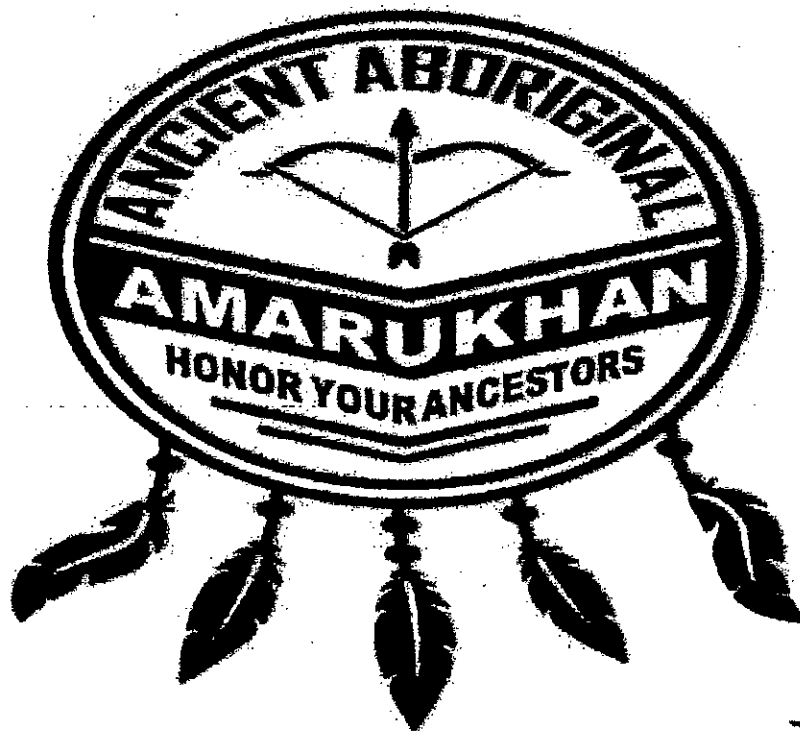

# To All Whom These Presents Shall Come

## Act of Union

In the name of the indigenous peoples of the Americas;

Whereas, our ancient aboriginal ancestors, the Niiji peoples of Turtle Island, have existed as a separate and distinct Nation of peoples, in the possession and exercise of the essential and appropriate attributes of sovereignty, from a period extending into antiquity, beyond the records and memory of man; and whereas, these attributes, with the rights and franchises which they involve, remain still in force and virtue, as do also the national and social relations of the indigenous peoples of the Americas to each other and to the body politic; it has become essential to the general welfare that a union should be formed, and a system of government matured, adapted to our present condition, and providing equally for the revitalization and protection of each Niiji individual who self-identify as the indigenous peoples of the Americas in the enjoyment of all our human rights and fundamental freedoms as the indigenous peoples of the Americas.

Therefore, we the indigenous peoples of the Americas also known as the Niiji peoples of Turtle Island now known as North America, do hereby solemnly enter into a social compact and mutual agreement to form ourselves into one body politic, under the style and title of the "Olmec Office of Sovereign Political Power Holders".

In view of this social compact and union now formed, and for the purpose of making satisfactory adjustments of all unsettled business which may have arisen before the consummation of this union, each one of us agree that all former social compacts and business that we may have been party to with any Nation, State, Country, organ of society, corporation, organization, people, person or construct of law shall be an absolute nullity to the provisions of the respective laws under which they originated, and that the Olmec Office of Sovereign Political Power Holders which we have established herein shall be governed in our own decisions accordingly. And also, that we claim all rights, interest and titles to the identity in the indigenous peoples of the Americas, the territorial property and lands in the North American Continent, and which shall henceforward vest entirely and unimpaired in the Olmec Office of Sovereign Political Power Holders, as constituted by this social compact and union.

## Preamble

We, the indigenous peoples of the Americas, conscience of our desire to be free from all tyranny and oppression; in order to form a more perfect Union and reestablish justice, secure the blessings of Liberty, insure domestic Tranquility, provide for the common defence and promote the general Welfare, hereby establish and ordain this Constitution and Laws for the security, protection and benefit of ourselves and our future generations to come that might not hear our declaration of peace and equality on this Great territorial property and Land of Turtle Island now called "North America"; and declare that the time has arrived when Our physical, political, cultural, social and economic condition ought to be forever altered and reestablished in North America; that Our inalienable right to exist as a sovereign state be asserted; and that we declare and revitalize our aboriginal title in the territorial property and Land in North America.

**Convinced**, that the historic mission of the indigenous peoples of the Americas is to offer to man a land of liberty, fundamental freedoms and a favorable environment for the development of his personality and the realization of his just aspirations and independent human rights;

**Confident**, that the true significance of the indigenous peoples of the Americas solidarity and good neighborliness can only mean the consolidation on this American Continent, within the framework of democratic institutions, of a Compact of individual freedom of thought and action, and a social compact based on respect for the inalienable rights of all humans beings;

**Conscious**, that the historic mission has already inspired numerous agreements, whose essential value lies in the desire of the indigenous peoples of the Americas to live together in peace and through their mutual understanding and respect for the sovereignty of each to provide for the betterment of all human beings, in independence, in equality and under the Laws of the Universe, the Law of Nature and the Law of Nations;

**Convinced**, that a union by and between the indigenous peoples of the Americas in Social Compact is an indispensable condition for the stability, peace and development of this Constitution and Laws;

**Convinced**, that juridical organization is a necessary condition for security and peace founded on moral order and justice of the Human rights of the indigenous peoples of the Americas and people of all Nations, States and Countries;

**In accordance with**, the first convening of the Assembly of the Olmec Office of Sovereign Political Power Holders in an effort to promote fundamental freedom of the Niiji people of Turtle Island from tyranny and oppression;

**HAVE AGREED** upon the following Articles of Organization for the Assembly of the Olmec Office of Sovereign Political Power Holders in the American Continent.

## **Article I.**

### **Nature and Purpose**

The Olmec Office of Sovereign Political Power Holders, established by this Constitution and Laws, is an Alliance that the Assembly of the Olmec Office of Sovereign Political Power Holders has developed to obtain the end and object of society; to revitalize our identity in the indigenous peoples of the Americas also known as the Niiji peoples of Turtle Island, which achieve an order of peace and equality; to promote its solidarity; to strengthen its collaboration; to defend its sovereignty, its territorial property, land, integrity and its independence; and to create a nation in a perfect state, thereby its Niiji peoples may benefit from the same condition. Within the Earth and international plane, the Assembly of the Olmec Office of Sovereign Political Power Holders is a collective body politic formed in accordance with the Law of Nations.

The Assembly of the Olmec Office of Sovereign Political Power Holders, in order to put into practice the principles on which it is founded and to fulfill its obligations under the Law of Nations, proclaims the following essential purposes:

- a) to strengthen the peace, human rights, fundamental freedoms and equality of all members of the human family;
- b) to promote and consolidate the personal property, territorial property, land, human rights, fundamental freedoms and independence of the indigenous peoples of the Americas, with due respect for the principle of nonintervention unless requested by one of us;
- c) to prevent possible causes of difficulties and to ensure the settlement of disputes that may arise among the Constituent Members and between Constituent Members and foreign Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas ;

- d) to provide for common action on the part of the Assembly of the Olmec Office of Sovereign Political Power Holders in the event of aggression aimed against any one of us;
- e) to seek the solution of political, juridical, cultural and economic problems that may arise among the Assembly of the Olmec Office of Sovereign Political Power Holders;
- f) to promote, by cooperative action, our political, cultural, economic and organizational development;
- g) to eradicate extreme poverty, which constitutes an obstacle to the full economic development of our social compact and union within the American Continent without debt; and
- h) to achieve an effective limitation of ignorance that will make it possible to devote the largest amount of resources to the economic and organizational development of our social compact and union.

## **Article II. Homestead**

We, the indigenous peoples of the Americas, reserve the right to claim commercial domicile, corporate domicile, domicile of choice, domicile of origin, domicile of succession, matrimonial domicile, and national domicile in Turtle Island now known as North America and any real property conveyed or transferred to a land trust rent-free and without charge during our social compact and union, it being the intent of this provision to preserve the requisite ownership, beneficial interest and possessory right in and to such real property in accordance with the Law of Nations; United Nations, Declaration on the Rights of Indigenous Peoples; and the Organization of American States, American Declaration on the Rights of Indigenous Peoples.

As the indigenous peoples of the Americas; we are Nijji people who inherently possess the right to self-determination and sovereign political power to freely pursue political, governmental, economic, social and cultural development as ancient peoples of Turtle Island; therefore, by virtue of the supreme authority and sovereign political power inherent in us, we do hereby establish, enact and title this instrument "The Olmec Office of Sovereign Political Power Holders Constitution and Laws", as a Supreme Legislation that is incapable of being repealed, annulled, or controlled by any other body politic or legislative authority; establish a sovereign state, self-identification, self-determination, inalienable rights, human rights, fundamental freedoms, independence and autonomy; and which establish vested ownership and aboriginal title in the territorial property and land in the Continent of the Americas, and more specifically in North America. That which also establish and create the Olmec Office of Sovereign Political Power Holders as a Sovereign State of self-government; to prescribe for the powers, duties, and jurisdiction thereof; it may establish other certain entities within the Olmec Office of Sovereign Political Power Holders as inferior organizations, and to prescribe for the powers, duties and jurisdiction thereof; and which repeal all acts and parts of acts which are inconsistent with or repugnant to any provision of this Constitution and Laws.

This Constitution and Laws shall be understood and due , as the common standard for all Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons, to the end; that they keep this Constitution and Laws constantly in mind and in record, and to strive to promote recognition, observation, respect and obedience of this Constitution and Laws; and by all progressive measures, national and international, we do hereby publish this Constitution and Laws for all to observe, recognize, respect and obey; bona fide.

### **Article III.**

#### **True and Correct Identity**

We, the indigenous peoples of the Americas, collectively hereby declare that we self-identify as: the Niiji people of Turtle Island now called North America in the American Continent; that we are the posterity of the Niiji peoples, an ancient and aboriginal Amarukhan peoples who are the true and correct sovereignty in North America and the American Continent; we shall make transactions as a moral person on the international plane as a sovereign state; and we are assembled as one pursuant to this social compact and union, we are hereby exercising supreme authority, sovereign political power and self-determination to revitalize our Niiji aboriginal identity and culture, the title to and vested ownership in our territorial property and land in North America and the American Continent, by and through our sovereign state, "Olmec Office of Sovereign Political Power Holders".

### **Article IV.**

#### **Rule of Law**

We, the indigenous peoples of the Americas, expressly maintain and believe that we possess the supremacy of inherent power, naked power, proprietary power, private power, public power, reserved power, resulting power, beneficial power, power of appointment, power over oneself, power over other persons, and power of revocation to enforce and protect our identity, territorial property, land, interest, rights, fundamental freedoms and personal property pursuant to: (1) International Law; the body of conventional laws which derive their authority directly from the Law of Nations; (2) Supreme Legislation; the body of laws which derive their authority directly from the Olmec Ambassador which are enacted as special law; and (3) Constitutional Law; the body of laws which derive their authority directly from the Assembly of the Olmec Office of Sovereign Political Power Holders which are enacted as internal law.

### **Article V.**

#### **Accession and Ratification Clause**

We, the indigenous peoples of the Americas, hereby declare that we were physically born as aboriginal Niiji people, melanated copper color human beings and the sovereignty in North America and the American Continent; we claim nationality and status in the moral person known as the "Olmec Office of Sovereign Political Power Holders", it is our belief that the Nations, States and Countries who are members of the Organization of American States and Assembly of the American Continent occupy this territorial property and land by force; but that we possess vested ownership and aboriginal title in this territorial property and land in North America and the American Continent; therefore, the indigenous peoples of the Americas who are Constituent Members of the Olmec Office of Sovereign Political Power Holders, shall possess the sovereign political power to command the members of the Charter of the Organization of American States and the Charter of the American Continent, its governments, corporations, organs of society, organizations, peoples, persons and citizens in matter in deed.

We hereby acknowledge, recognize, and ratify the following treaties in order to support our social compact and union as a sovereign state, to wit:

1. the Law of Nations;
2. the Charter of The United Nations and Statute of The International Court of Justice;
3. the United Nations, Universal Declaration of Human Rights;
4. the United Nations, International Covenant on Civil and Political Rights;
5. the United Nations, International Covenant on Economic, Social and Cultural Rights;
6. the United Nations, Declaration on the Rights of Indigenous Peoples;
7. the Organization of American States, American Declaration on the Rights of Indigenous Peoples;
8. the Charter of the Organization of American States; and
9. the Charter of the American Continent.

## **Article VI.**

### **Bill of Rights**

We, the Nijji peoples of Turtle Island assembled in the Olmec Office of Sovereign Political Power Holders, in our capacity and status as the Indigenous Peoples of the Americas, the ancient Amarukhan and Sovereignty; do hereby establish this Bill of Rights which set forth other certain inalienable rights, human rights and fundamental freedoms to be retained by us in this Constitution and Laws; these inalienable rights, human rights and fundamental freedoms, shall at all times be retained by us in this Constitution and Laws as personal property, intellectual property and incorporeal property to be held by each individual Nijji people and at no time shall they be infringed upon or encroached by any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence; these particular inalienable rights, human rights and fundamental freedoms cannot and shall not be denied by, disparaged by, or transferred or surrendered to any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence, except that which is expressly vested by this Constitution and Laws; to wit:

1. The principles of the Law of Nature and the Law of Nations;
2. Right of action: a right that can be enforced by legal action, a chose in action;
3. Right of entry: a right of taking or resuming possession of land or other real property;
4. Right of family integrity: a fundamental right for a family unit to be free of unjustified state interference;
5. Right of first publication: a property right that arise when the work is created, rather than when it is published;
6. Right of possession: a right to hold, use, occupy, or otherwise enjoy any given property;
7. Right of privacy: a right to personal autonomy;
8. Right of publicity: a right to control the use of our own full names, pictures, or likeness and to prevent another from using it for commercial benefit or transactions without written consent;
9. Right of revolution: an inherent right to cast out Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons within the territory of North America and the American Continent by force or general uprising when the legal methods of making such changes have proved inadequate or are so obstruct as to be unavailable, and to change our polity or effect radical reforms in our system of government or institutions for our security, protection and benefit;
10. Right of support: a right as the landowner in the territorial property and land of North America to have the land supported by adjacent land, air, and by the underlying earth and waters;
11. Right of termination: a right to a remedy involving the ending of contractual relations, accorded when the other party breaches a duty that arises under the contract;

12. Right of attribution: the right to be credited as a works author, to have a name appear in connection with a work, or to forbid the use of a name in connection with a work;
13. Right of assembly: the right as the indigenous peoples of the Americas to gather for public expression of religious liberties, political and cultural beliefs, economic relief or grievances in any place on the American Continent;
14. Right to bear arms: the right to possess, use, or own firearms and weapons of choice;
15. Right to exclude: the indigenous peoples right to prevent others from making, using, selling, or offering for sale land, a creative works, inventions or instruments protected by copyright or patent in the jurisdiction, territorial property and land in North America and the American Continent;
16. Right to pursue happiness: the right to pursue any business, transaction, contract or activity that might yield the highest enjoyment, increase prosperity, or allow for the development of economic faculties;
17. Right to travel: the right to travel freely upon the earth and beyond with the undiminished freedom of movement without legal duties or foreign jurisdiction being imposed;
18. Freedom of association: the right to join with other Niiji peoples collectively in a common undertaking that would be lawful if pursued individually;
19. Freedom of expressive association: the right to associate with other Niiji peoples, without undue interference, for the purpose of engaging in activities such as commerce, contracts, speech, assembly, leisure, culture and religion;
20. Freedom of intimate association: the right of privacy to form and preserve certain natural intimate human relationships without intrusion or undue interference;
21. Freedom of choice: the liberty to exercise right of privacy, personal decisions and actions;
22. Freedom of contract: the right to bind oneself or others legally by written contract or arrangement without external control outside the parties engaged in the transaction except by written consent;
23. Freedom of expression: the freedom of speech, press, assembly, culture or religion without interference or external control;
24. Freedom of speech: the undiminished right to express thoughts and opinions;
25. Freedom of the press: the right to create, print and publish materials and works;
26. The right to maintain and solely possess ownership of one's physical body, Certificate of Live Birth, appellation and self-identification as the indigenous peoples of the Americas and Niiji peoples;
27. The right to maintain one's life, sound mind, holy spirit, free will, personal decisions and actions;
28. The right to maintain capacity and status as one individual and/or as a collective body politic of indigenous peoples of the Americas and Niiji peoples, sovereign political power within the territorial property and land in North America and the American Continent, independence, autonomy and every power, right, interest and jurisdiction;
29. The human right to declare and maintain self-determination; self-identification; fundamental freedoms; independence; autonomy; and to abjure from the realm, jurisdiction, or citizenship of any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence;
30. The right to perpetually maintain absolute immunity, diplomatic immunity, foreign immunity, sovereign immunity, charitable immunity, husband-wife immunity, testimonial immunity, transactional immunity, and use immunity;
31. The right to maintain an undiminished natural liberty;
32. The right to be secure in ones physical body from any form of assault, imprisonment, slavery, servitude, bondage, or search or seizure;
33. The right to perpetually maintain autonomy privacy and informational privacy, and to be free from intrusion or invasion of privacy;
34. The right to maintain residence, commercial domicile, corporate domicile, matrimonial domicile, national domicile, domicile of choice, domicile of origin, and domicile of succession any place within the territorial property and land in North America and the American Continent or on Earth;

35. The right to maintain beneficial ownership, perfect ownership, beneficial interest and right of possession in the rights established by the United Nations: Charter, Universal Declaration of Human Rights and the Declaration on the Rights of Indigenous Peoples; and the Charter of the Organization of American States: American Declaration on the Rights of Indigenous Peoples;
36. The right to maintain interest, corporeal ownership, incorporeal ownership, vested ownership, aboriginal title, absolute title, clear title, equitable title, good title, lucrative title, paramount title, perfect title, record title, and right of possession in the territorial property and land owned by the indigenous peoples of the Americas within Turtle Island now known as North America and the American Continent;
37. The right to maintain interest, corporeal ownership, incorporeal ownership, vested ownership, aboriginal title, absolute title, clear title, equitable title, good title, lucrative title, paramount title, perfect title, record title, jurisdiction and right of possession in the territorial property and land occupied by the Nations, States, and Countries who are members of the Charter of the Organization of American States and the Charter of the American Continent;
38. The right to exercise sovereign political power as an individual Nijji/Indigenous peoples of the Americas and to exercise and impose jurisdiction over the territorial property and land, Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the American Continent;
39. The right to perpetually maintain a tax exempt status and to be free of any form of debt imposed or incurred by the foreign Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property, land and jurisdiction in North America and the American Continent;
40. The right to acquire, own, and maintain corporeal and incorporeal property;
41. The right to be secure in the possession of any corporeal or incorporeal property;
42. The right to travel the Earth and beyond with the undiminished freedom of movement without legal duty or jurisdiction being imposed by any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence;
43. The head of an estates' right to maintain their natural family as the patria potestas with the undiminished freedom to wed and/or procreate with more than one human being without legal duty or jurisdiction being imposed by any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence;
44. The freedom of choice to maintain the rights and fundamental freedoms outlined within the Charter of the Kingdom of Turtle Island which are not repugnant to this Constitution and Laws;
45. The freedom of choice to maintain the rights and fundamental freedoms outlined within the United Nations: Charter and Universal Declaration of Human Rights which are not repugnant to this Constitution and Laws;
46. The freedom of choice to maintain the rights and fundamental freedoms outlined within the United Nations: Declaration on the Rights of Indigenous Peoples which are not repugnant to this Constitution and Laws;
47. The freedom of choice to maintain the rights and fundamental freedoms outlined within the Organization of American States: American Declaration on the Rights of Indigenous Peoples which are not repugnant to this Constitution and Laws;
48. Our right to the recognition, respect, observance and enforcement of treaties, agreements and other constructive arrangements concluded between the indigenous peoples of the Americas and other Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples, persons and constructs of law, or their successors and to have them honour and respect such treaties, agreements and other constructive arrangements which are not repugnant to this Constitution and Laws.

## Article VII. Principles

The indigenous peoples of the Americas, assembled herein as the Nijji peoples of the Olmec Office of Sovereign Political Power Holders, affirms the following principles:

- a) the Law of Nature and the Law of Nations is the standard of conduct in the Assembly of the Olmec Office of Sovereign Political Power Holders and its Constituent Members and Citizens in their reciprocal relations with foreign Nations, States and Countries;
- b) international order consist essentially of the Assembly of the Olmec Office of Sovereign Political Power Holders respect for the personality, sovereignty, and independence of foreign Nations, States and Countries, and the faithful fulfillment of obligations derived from treaties and other sources of the Law of Nations;
- c) good faith shall govern the relations between the Assembly of the Olmec Office of Sovereign Political Power Holders and foreign Nations, States and Countries;
- d) the solidarity of the Assembly of the Olmec Office of Sovereign Political Power Holders and the high aims which are sought through it require the political organization of those Constituent Members and Citizens on the basis of the effective exercise of unencumbered Human Rights of the indigenous peoples of the Americas and for other peoples, Nations, States and Countries;
- e) every Constituent Member and Citizen of the Assembly of the Olmec Office of Sovereign Political Power Holders has the right to choose, without external interference, their cultural, political, economic, and social condition and to organize themselves in the way best suited to them, and has the duty to abstain from intervening in the affairs of any other Constituent Member; subject to the foregoing, Constituent Members and Citizens shall cooperate fully among themselves, independently of the nature of their political, economic and social condition;
- f) the elimination of extreme poverty is an essential part of the promotion and consolidation of unencumbered Human Rights of the indigenous peoples of the Americas and each Nijji peoples a Constituent Member or Citizen, it is the common and shared responsibility of the Assembly of the Olmec Office of Sovereign Political Power Holders;
- g) the Olmec Office of Sovereign Political Power Holders condemns war of aggression: victory does not give rights;
- h) an act of aggression against one Constituent Member or Citizen is an act of aggression against all other Constituent Members and Citizens;
- i) controversies of an international character arising between a Constituent Member or Citizen of the Assembly of the Olmec Office of Sovereign Political Power Holders and a foreign Nation, State, government or its citizens, organ of society, corporation, organization, people or person shall be settled by peaceful procedures in the Olmec State Tribunal Court of Justice or the United Nations International Court of Justice;
- j) true empathy is the basis of lasting peace;
- k) economic cooperation is essential to the prosperity of the indigenous peoples of the Americas, Constituent Members and Citizens of the Assembly of the Olmec Office of Sovereign Political Power Holders;
- l) the Assembly of the Olmec Office of Sovereign Political Power Holders proclaims the Human Rights of the indigenous peoples of the Americas pursuant to the United Nations: Universal Declaration of Human Rights and Declaration on the Rights of Indigenous Peoples;
- m) the Assembly of the Olmec Office of Sovereign Political Power Holders proclaims the self-determination rights of the indigenous peoples of the Americas pursuant to the United Nations: Declaration on the Rights of Indigenous Peoples;



- n) The Assembly of the Olmec Office of Sovereign Political Power Holders proclaims the self-identification and self-determination rights of the indigenous peoples of the Americas pursuant to the Organization of American States: American Declaration on the Rights of Indigenous Peoples;
- o) the spiritual unity of the Assembly of the Olmec Office of Sovereign Political Power Holders is based on respect for the cultural values and human rights of other members of the human family and requires its close cooperation for the high purposes of peace;
- p) the education of the Constituent Members and Citizens of the Olmec Office of Sovereign Political Power Holders shall be directed toward equality of suffrage, freedom of thought, invention, and Intellectual Property protection for a lasting prosperity and the understanding of the Human Rights of the human family.

## **Article VIII.**

### **Olmec Office of Sovereign Political Power Holders; Powers and Duties; Territorial Property and Jurisdiction; Public Officers and Employees; Immunities; Oaths**

1. There is hereby created within the indigenous peoples of the Americas inherent in us, an Olmec Office of Sovereign Political Power Holders, hereafter, the Olmec State; the Olmec State shall perpetually function as a governmental trust, public utility, moral person and person of inherence within the territorial property and land in Turtle Island now known as North America and the American Continent, and shall be the sole sovereign state of self-government exercised by and for the self-determination, security, protection, and benefit of the Olmec State and its beneficiaries, constituent members, citizens and contractors party to this instrument, both, separately and independent of any Nation, State, organ of society, government or its citizens, corporation, organization, group, people, person, or construct of law in existence; the Olmec State shall possess a seat of government at an executive office area within the territorial property and jurisdiction of the indigenous peoples of the Americas in the American Continent;
2. The Olmec State shall consist of the beneficiaries, constituent members, citizens and contractors party to this Constitution and Laws and shall be governed by the Assembly of the Olmec Office of Sovereign Political Power Holders ;
3. The Olmec State shall retain the inherent sovereignty of the indigenous peoples of the Americas and sovereign political power to execute self-determination to govern itself as a sovereign state; exercise supreme authority, executive powers, legislative powers, judicial powers, and spending powers over foreign Nations, States, governments and its citizens operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; interest in the obligations owed by the United Nations, Organization of American States and its members, Assembly of the American Continent and its members, United States and its member States and citizens, and the approximately 567 federally-acknowledged and recognized indian tribes within the United States; aboriginal title, absolute title, clear title, equitable title, good title, lucrative title, paramount title, perfect title, record title, and right of possession in the territorial property and land of Turtle Island now known as North America and the American Continent; vested ownership and financial interest in the tangible property attached to the land within the territorial property and land in Turtle Island now known as North America and the American Continent; Proprietary capacity to own, control, use, maintain and operate commercial enterprises and authorize transactions in the name of the indigenous peoples of the Americas, Niiji peoples and the Olmec Office of Sovereign Political Power Holders for economic development; and the right of publicity and title to the indigenous peoples of the Americas, Niiji peoples and Olmec Office of Sovereign Political Power Holders;
4. Each branch of the Assembly of the Olmec State shall not exercise the political power of any other branch, except that which is conveyed by this Constitution and Laws;

5. The Olmec State shall possess aboriginal title to, vested ownership in, consist of in part and jurisdiction over the territorial property and land embraced within the following boundaries occupied by the people of the United States and its several States and the approximately 567 federally recognized Indian Tribes in the United States, to wit: Turtle Island now North America being occupied by the United States and Canada;
6. The Olmec State shall also possess jurisdiction over, right of possession to, corporeal ownership of and the sovereign right in the Charter of the Organization of American States, the Charter of the American Continent, and the approximately 567 federally-acknowledged and recognized Indian tribes existing within the territorial property, land and jurisdiction in North America and the American Continent; and to regulate and command these Organizations and Indian tribes of the same of our treaties, contracts, agreements or arrangements which may be made by operation of law;
7. The Olmec State shall also possess jurisdiction over, right of possession to, and corporeal ownership of all property (tangible and intangible) that is within the possession of all Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples or persons who are members of the Organization of American States and the Assembly of the American Continent and existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
8. The Olmec State shall solely possess and retain the supreme authority and sovereign political power to legislate, govern, and adjudicate throughout the territorial property, land and within the jurisdiction of the indigenous peoples of the Americas, the Olmec State and internationally; to appropriate public funds, resources and revenue from the Organization of American States and the Assembly of the American Continent, and the approximately 567 federally recognized Indian tribes within the United States; to lay and collect taxes, duties, impost, and excises from all Nations, States, governments and its citizens, organs of society, corporations, organizations including but not limited to the Organization of American States and the Assembly of the American Continent, groups, peoples, persons and construct of laws created by them and acting within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to pay the debts and to provide for the benefit, common defense, and general welfare of the indigenous peoples of the Americas and the Olmec State; to borrow money, currency or resources on the full faith and credit of the Olmec State; to regulate commerce and commercial enterprises within the territorial property and jurisdiction of the Olmec State; to regulate banks and banking within the territorial property and jurisdiction of the Olmec State; to regulate agriculture and farming within the territorial property and jurisdiction of the Olmec State; to regulate, fund, construct and maintain educational programs and institutions and land tenure systems within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to create, maintain, and regulate patents, copyrights, and copyright ownership of any entity or person of their respective writings, discoveries, and inventions who are within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State at the time of such creations; to regulate and issue titles, deeds, licenses, registrations, and certificates within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to regulate and issue money, currency, coin money and regulate the value thereof, and to regulate the value of foreign currency and coined money within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to mine resources from Earth within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to provide for the punishment of counterfeiting the resources, securities, money and currency, respective copyrights and patents of the Olmec State; to own, control, maintain, and operate commercial and business enterprises within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to acquire and maintain any form of corporeal or incorporeal property within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to establish and maintain a public law of naturalization and immigration within the territorial property, land and jurisdiction of the Olmec State; to establish and maintain a public law on the subject of bankruptcy within the territorial property, land and jurisdiction of the Olmec State; to declare war, grant letters of marque and reprisal, and make rules or regulations concerning capture or arrest on land

and water within the territorial property, land, waters and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to establish and maintain a militia to execute the laws, suppress insurrections, and repel invasions throughout the territorial property, land, waters and jurisdiction in the American Continent and for the security, protection and benefit of the Beneficiaries, Constituent Members and Citizens of the Olmec State; and to exercise sovereignty and supreme legislation throughout the territorial property, land, waters and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and to own, hold, use, occupy or destroy any property in the possession of any Nation, State, government, citizen of a government, organ of society, corporation, organization, group, people, person or construct of law that is a member of the Charter of the Organization of American States and the Charter of the American Continent which is within the territorial property, land, waters and jurisdiction of the indigenous peoples of the Americas and the Olmec State;

9. There shall be a great seal of the Olmec Office of Sovereign Political Power Holders, and its use shall be for the performance, execution, or financing of all official State or governmental operations of the indigenous peoples of the Americas who proclaim that they are the ancient and aboriginal Niiji people; and are the true and correct Sovereignty of the American Continent;
10. The Olmec Ambassador shall possess the supreme authority and retain the powers, rights, capacities, status, jurisdiction and venue vested within the indigenous peoples of the Americas and the Olmec State in order to effectively exercise official State and governmental operations of the indigenous peoples of the Americas and the Olmec State;
11. The Olmec Ambassador shall possess absolute immunity, foreign immunity, intergovernmental immunity, sovereign immunity, charitable immunity, and testimonial immunity, and be perpetually absolved from any responsibility for damage or any other liability arising from the transaction of some penalty enforced by any Nation, State, government, organ of society, corporation, organization, group, people, person or construct of law in existence which shall be a separate entity from the indigenous peoples of the Americas and the Olmec State;
12. The Olmec Ambassador shall administer all personnel functions; be the appointing authority of all officers; may enter into contracts, agreements or arrangements for the benefit of the indigenous peoples of the Americas and the Olmec State; and may enter into contracts, agreements and arrangements with any private person or entity to serve with or perform specific functions or services for the Olmec State;
13. The Olmec Ambassador may enter into or enforce contracts, agreements or arrangements with the United Nations, Organization of American States, the assembly of the American Continent or any one or more of the several Nations, States or Countries who are members of the United Nations, Organization of American States, assembly of the American Continent, and any foreign Nation, State, or government and any of the International Organizations or political subdivisions thereof;
14. All Beneficiaries, Constituent Members, Citizens, Officers employed or in contract agreement, volunteers and employees hired by the Olmec State, shall be under the direction and supervision of the Ambassador, and are required to discharge their duties and perform their functions in secrecy;
15. All Beneficiaries, Constituent Members, Officers employed or in contract agreement, volunteers and employees hired by the Olmec State, shall perform any duties or render any services in furtherance of the purposes, obligations and intentions of this Constitution and Laws and, absent any showing of fraud or bad faith, they shall be under no liability and possess absolute immunity, foreign immunity, intergovernmental immunity, sovereign immunity, charitable immunity, testimonial immunity and be held harmless, and may be delegated political powers, unless otherwise stated by the Ambassador, to effectively exercise their duties and perform their functions in secrecy;

16. All Beneficiaries, Constituent Members, Citizens, Officers employed or in contract agreement, volunteers and employees hired by the Olmec State, shall, before entering upon the duties and obligations of their respective offices, take and subscribe to the following written oath or affirmation: "I, \_\_\_\_\_, do solemnly swear (or affirm) that I will support, respect, observe, and abide by this Constitution and Laws, all rules, regulations, orders, commands and supreme legislations enacted by the Olmec Office of Sovereign Political Power Holders; the Law of Nations; the United Nations Charter; the United Nations Universal Declaration of Human Rights; the United Nations Declaration on the Rights of Indigenous Peoples; and the Organization of American States American Declaration on the Rights of Indigenous Peoples; and that I will faithfully discharge the duties and functions of the Office of \_\_\_\_\_, discreetly and in secrecy according to the best of my ability."

## **Article IX.**

### **Olmec State Legislative Council; Powers and Duties; Supreme Legislation; Rules and Regulations**

1. There is hereby established within the Olmec State, a Legislative Council, hereafter, the Olmec Council; the Olmec Council shall possess the sovereignty, jurisdiction, and legislative power to create a supreme legislation and laws in the name of the indigenous peoples of the Americas and the Olmec State;
2. The legislative power of this sovereign state is vested exclusively in the Olmec Council which shall be divided into the Olmec State Ambassador, twelve Senior Councilors, and 36 Legislative Councilors; administrative functions shall be performed by Olmec State employees and contractors;
3. The Olmec State Ambassador shall possess, the sovereign political power to ordain, establish, order, and enact supreme legislations for the security, protection and benefit of the Olmec State; all supreme legislations are a fundamental law which are incapable of being altered, revised, repealed, rescinded, annulled, amended, or controlled by any foreign Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person, or construct of law in existence; and all supreme legislations shall have precedence over any subordinate legislation enacted by any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person or construct of law existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
4. The Olmec State Ambassador may record an authenticated and certified copy of any supreme legislation with the United Nations; the Organization of American States; or the assembly of the American Continent with the purpose to publish, enforce, and make it effective as a general law and special law; the Olmec State Ambassador may also enforce and give immediate effect as a general law and special law to a supreme legislation or any legal document or instrument by so stating, signing, dating, and to seal it with the great seal of the Olmec State;
5. The Olmec State Senior Councilors, hereafter, Sr. Councilors, are responsible for ordering and enacting rules and regulations; enacting operating procedures and memoranda created by the Olmec State Legislative Councilors, the Olmec State Bureau of Investigations, the Olmec State Tribunal Court of Justice, the Olmec State Treasury of Budget and Finance Commision, and the Olmec State Commercial Economic Corporation; all rules and regulations ordered or enacted are substantive law and territorial law which are incapable of being altered, revised, repealed, rescinded, annulled, amended, or controlled by any Nation, State, government, organ of society, corporation, group, peoples, person, or construct of law in existence except that which may be done by the Olmec Ambassador; and all rules and regulations shall have precedence over any legislation enacted by foreign Nations, States, governments, organs of society, groups, peoples, persons or constructs of law existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;

6. The Sr. Councilors may file an authenticated and certified copy of any rules and regulations, operating procedures or memoranda with the United Nations, the Organization of the American States or the assembly of the American Continent with the purpose to publish, enforce, and make it effective as a general law and special law; the Sr. Councilors may also enforce and give immediate effect as a general law and special law to rules and regulations, operating procedures or memoranda by so stating, signing, dating, and use of the great seal of the Olmec State;
7. The Sr. Councilors shall directly supervise and administer specific legislative functions to the Legislative Councilors and Olmec Council employees, but shall report to the Olmec Ambassador on all substantive legislative issues;
8. The Olmec Council Legislative Councilors, hereafter, the Council, shall perform any function administered by the Olmec Ambassador and Sr. Councilors; the Council shall possess the sovereign political power to legislate supreme legislation, rules and regulations, and memoranda for the security, protection, and benefit of the indigenous peoples of the Americas and the Olmec State;
9. The Sr. Councilor may, with the written approval of the Olmec Ambassador, command the assistance of the United Nations, the Organization of American States, the Assembly of the American Continent, the United States and the several states, and any Nation, State, government and its officers, organ of society, corporation, organization, group, people, person, or construct of law existing within the territorial property, land and jurisdiction of the Indigenous Peoples of the Americas and the Olmec State which shall provide the assistance commanded without delay.

## **Article X.**

### **Olmec State Board of Democracy Yeomanry; Jurisdiction; Powers and Duties**

1. There is hereby established within the Olmec State, a Board of Democracy Yeomanry, hereafter, the Olmec BODY; the Olmec BODY shall possess the sovereignty, jurisdiction, and executive power superior to that of any executive branch of government existing and operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and Olmec State; the Olmec BODY may convene at the executive office at the seat of government or by electronic device;
2. The executive power of this Sovereign State is vested in the Olmec BODY, which shall be divided into one President, one Vice President, Constituent Members, many Citizens and inferior organizations created by it; administrative functions shall be performed by Olmec State Employees or contractors;
3. The Olmec BODY shall possess the jurisdiction and sovereign right to exercise sovereign political power, collectively or individually, over the subordinate political powers of all Nations, States, governments and their citizens, organs of society, corporations, organizations, groups, peoples, persons or construct of laws existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
4. The Olmec BODY shall perpetually constitute a republic form of self-government in which the supreme power and supreme authority is retained as personal property by each Constituent Member and Citizen and held in this instrument through the: Olmec Office of Sovereign Political Power Holders;
5. The Olmec President shall be commander-in-chief of the Olmec Army and Navy of this Sovereign State, and commission all Officers and offices under his authority of their duties;

6. The Olmec President shall possess the supreme authority and executive power to transact any and all necessary business with offices and officers of the Nations, States, Countries and governments exercising political power within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and may require information, in English writing, from the offices or officers within the legislative, executive, judicial, and local branches of government of the same, upon any subject relating to their duties and obligations, pursuant to international law, of their respective offices; and they shall take care that the laws of the Olmec State be faithfully recognized and executed for the security, protection and benefit of the indigenous peoples of the Americas and the Olmec State;
7. The Olmec President shall possess the supreme authority and sovereign political power to faithfully execute the laws of the Olmec State and inquire into the condition and administration of any acts of any public office, public officer, employee or volunteer acting under the jurisdiction of any government which is within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and may hold liable, any of these public offices, public officers, departments, organs of society, corporations, organizations, citizens, peoples, persons, employees or volunteers for gross neglect of duty, corrupt conduct in office, malfeasance, misfeasance, or nonfeasance therein, or for aiding, abetting or conspiring with any other in an act of aggression against the supreme authority and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
8. The Olmec President shall possess the supreme authority and sovereign political power to convene any public officer within the executive, legislative, judicial, or local branches of government exercising political power within the territorial property and land of the indigenous peoples of the Americas and the Olmec State on any occasion or extraordinary occasion;
9. The Olmec President shall possess, with the written approval of the Olmec Ambassador, the supreme authority and sovereign political power to grant reprieves, commutations and pardons of criminal convictions or civil orders against individual indigenous peoples of the Americas and the Assembly of the Olmec State, who are being held liable or unlawfully detained under the foreign jurisdiction of any Nation, State, government, organ of society, corporation, organization, group, people, person or construct of law existing, for any and all charged offenses, upon such conditions, restrictions and limitations as the Olmec President may deem just and proper; and to ratify existing Treaties relating to the indigenous peoples of the Americas;
10. The Olmec Ambassador and President shall each be provided an annual compensation in full payment for all services performed, plus per diem compensation for expenses incurred; a permanent residence and recreational residence suitably furnished and secured; transportation suitable for local, national and international travels; and personal security forces;
11. The Olmec BODY Vice President, shall possess the supreme authority and sovereign political power to perform duties commanded by the Olmec Ambassador and Olmec President, but shall not be delegated the sovereign political power or supreme authority to create, amend, repeal or enact legislation; in a case of the incapacity or death of the Olmec President, the Vice President shall temporarily maintain limited authority as the Olmec President until his return, not to exceed a 9 month term, or until a successors commencement as the Olmec President, which shall be named within the secret trust or mystic will of the current Olmec Ambassador; and shall command, supervise and administer specific functions to any officers, contractors, employees, foreign Nations, States, Countries, governments and its citizens, organs of society, corporations, organizations, groups, peoples, or persons existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
12. The Olmec BODY Vice president shall be provided an annual compensation to be dispersed in monthly installments for all services performed, plus a per diem compensation for expenses incurred; a permanent residence suitably furnished and secured; transportation suitable for local and national travel and personal security forces;

13. The Olmec BODY Constituent Members, hereafter, the Olmec BODY, shall consist of melanin copper color aboriginal indigenous peoples of the Americas, who (a) are domiciled within the territorial property, land and jurisdiction of the indigenous peoples of the Americas in the American Continent, (b) have abjured from the citizenship of any Nation, State, government, organ of society, corporation, organization, group or people, and (c) have pledged to and been registered with the Olmec Office of Sovereign Political Power Holders; the Olmec BODY shall further consist of, be a beneficiary of, or be contracted with the Olmec Office of Sovereign Political Power Holders; all Olmec BODY Constituent Members shall become beneficiaries in a donative trust created by the Olmec State; and shall possess the sovereignty and sovereign political power of this Sovereign State to exercise their individual or collective human rights any place in existence.
14. The Olmec BODY Citizens, hereafter, the Civil Society, shall consist of melanin copper color aboriginal indigenous peoples of the Americas, who (a) are domiciled within the territorial property, land and jurisdiction of the indigenous peoples of the Americas in the American Continent, (b) have abjured from the citizenship of any Nation, State, government, organ of society, corporation, organization, group or people, and (c) have pledged to and been registered with the Olmec Office of Sovereign Political Power Holders; the Civil Society shall possess the political power to participate in the political party of their choice that are composed of democratic or republican parties in the Olmec State in the exercise of their civic rights.

#### **Article XI.**

#### **Olmec State Tribunal Court of Justice; Jurisdiction; Venue; Powers and Duties**

1. There is hereby established within the Olmec State, a Tribunal Court of Justice, hereafter, the Olmec Tribunal; the Olmec Tribunal shall possess the sovereignty, jurisdiction and judicial power superior to that of any Nation, State, government, corporation or organization operating within the territorial property, land and jurisdiction of the Indigenous Peoples of the Americas and the Olmec State; the Olmec Tribunal may convene in any court of record located within the territorial property, land and jurisdiction of the Olmec State or at the seat of government of the Olmec State;
2. The judicial power of this Sovereign State is vested exclusively in the Olmec Tribunal which shall be divided into the Chief Judge, a panel of twelve Appellate Judges, Trial Judges, and Counsel Members; administrative functions shall be performed by Olmec State employees or contractors;
3. The Olmec Tribunal may exercise supreme authority, sovereign political power, jurisdiction and venue at the discretion of the Chief Judge; and shall possess judicial powers and jurisdiction to issue process of subpoena; administer oath to witnesses; hear and determine a genuine controversy; hear and determine civil and criminal matters; determine and issue prerogative and remedial writs; possess appellate, superintending control, and judicial review over all courts of record operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and devise and create inferior courts, judicial offices, new orders, rules and regulations, and operating procedures necessary to carry into effect the judicial powers, jurisdiction and venue possessed by them;
4. The Olmec Tribunal shall possess the proper venue when an action takes place within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State, or when a cause of action is commenced by the Olmec Bureau of Investigations in the name of the indigenous peoples of the Americas and the Olmec Office of Sovereign Political Power Holders for the use and benefit thereof, and when one or more individuals of the Olmec BODY commences a cause of action within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
5. The Chief Judge shall possess the supreme authority, judicial power and discretion to hear and determine all final appeals; and to approve all rules, regulations and operating procedures;

6. The Olmec Tribunal Appellate Adjudges, hereafter, the Panel, shall possess the judicial power and jurisdiction to hear and determine all preliminary appeals, and to create rules and regulations regarding judicial practice and procedure within its jurisdiction and venue; and shall act as a single appellate adjudge to hear and determine final appeals when delegated the authority to do so by the Chief Judge;
7. The Olmec Tribunal Trial Adjudges, hereafter, the Judges, shall possess all the powers, jurisdiction and venue outlined in paragraph 3 of this section to adjudicate all matters within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
8. The Olmec Tribunal Counsel Members, hereafter, the Counselors, shall provide all beneficiaries, constituent members, citizens, contractors and political and proprietary subdivisions within the Olmec State with legal representation and advice regarding matters of civil and criminal litigation, tort litigation, business and corporate laws, real estate laws, bankruptcy laws, estate laws, international laws and shall act as trial adjudge or appellate adjudge when delegated the authority by the Chief Judge; each Counselor shall be provided adequate Olmec State employees or contractors to assist in the exercise of the functions of this office.

## **Article XII.**

### **Olmec Bureau of Investigations; Jurisdiction; Powers and Duties**

1. There is hereby established within the Olmec State, a Bureau of Investigations, hereafter, the OBI; the OBI shall possess the sovereignty, jurisdiction, venue, military objective and police power superior to that of any military, law enforcement agency or police organization created by any Nation, State, government, organ of society, corporation, organization, group, people or construct of law existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; the OBI headquarters shall be located at the seat of government of the Olmec State;
2. The police power and military objective of this Sovereign State is vested exclusively in the OBI which shall be divided into the Captain, three General Prosecutors, twelve Directors, Ombudsmans, Commanding Officers, and Law Enforcement Officers; administrative functions shall be performed by Olmec State employees or contractors;
3. The Captain shall possess the supreme authority to execute and enforce all supreme legislations, rules and regulations enacted by the Olmec Council; to execute and enforce penal laws enacted by governments operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to serve process of subpoena issued by the Olmec Tribunal, lead investigations, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the supreme authority, military objective and police power of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; and to approve all rules and regulations;
4. The OBI General Prosecutors shall possess the supreme authority to prosecute any person in violation of supreme legislations, rules and regulations enacted by the Olmec Council, and penal laws enacted by governments operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to serve process of subpoena issued by the Olmec Tribunal, lead investigations, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the police power and military objective of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; to exercise any act prescribed by the rules and regulations regarding judicial practice and procedure required by the Olmec Tribunal; and to directly supervise and administer specific functions to the Ombudsmans and Commanding Officers, but shall report to the Captain on all substantive legal and investigative matters;



5. The OBI Directors shall possess the supreme authority to execute and enforce supreme legislations, rules and regulations enacted by the Olmec Council, and penal laws enacted by governments existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to prosecute any person in violation of supreme legislations, rules and regulations enacted by the Olmec Council; to serve process of subpoena issued by the Olmec Tribunal, lead investigations, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the police power and military objective of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; and to directly supervise and administer specific functions to the Ombudsmans, the Commanding Officers, and the Law Enforcement Officers, but shall report to the Captain and the General Prosecutor on all substantive legal and security matters;
6. The OBI Ombudsmans' shall possess the supreme authority to execute and enforce supreme legislations, rules and regulations enacted by the Olmec Council, and penal laws enacted by governments existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; to prosecute any person in violation of supreme legislations, rules and regulations enacted by the Olmec Council; to serve process of subpoena issued by the Olmec Tribunal, lead investigations, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the police power and military objective of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; and to directly supervise and administer functions to Commanding Officers, but shall report to the Captain, General Prosecutor and Director on all substantive investigative matters;
7. The OBI Commanding Officers, hereafter, the Commanders, shall possess the supreme authority and police power to serve process of subpoena issued by the Olmec Tribunal, lead investigations, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the sovereignty and police power of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; to secure, protect and serve the Olmec State Ambassador, President, Vice President, Constituent Members, Citizens and property by any means necessary, in any circumstance, at any place, and at any time; and to directly train, supervise, and administer specific functions to Law Enforcement Officers, but shall report to the Captain, General Prosecutor, Director and Commanding Officers on all substantive investigative information and security matters when ordered;
8. The OBI Law Enforcement Officers, hereafter, the Enforcers, shall possess the supreme authority and police power, and when delegated authority by the Olmec President, military jurisdiction to execute and enforce the military objective, martial law and/or war power; to investigate legal matters, file complaints, make arrest, detain suspects, obtain and store evidence, and to do all acts necessary to carry out the police power, military objective and military jurisdiction of this Sovereign State for the security, protection and benefit of the Olmec States legitimate interest; to secure, protect and serve the Olmec Ambassador, President, Vice President, Constituent Members, Citizens, its Officers, its contractors, its employees, its volunteers and property by any means necessary, in any circumstance, at any place, and at any time; and to directly train, supervise, and administer specific orders to the Olmec Militia troops pursuant to the military objective and military jurisdiction, but shall report to the Captain, Director, Ombudsmans, and Commanders on all substantive security matters;
9. The General Prosecutors and Directors may, with the written consent of the Captain, command the assistance of any Nation, State, Country, governmental office, officer, departments and agencies existing within the territorial property, land and jurisdiction of the Indigenous Peoples of the Americas and the Olmec State.

### **Article XIII.**

#### **Olmec Treasury of Budget and Finance Commission; Powers and Duties**

1. There is hereby established within the Olmec State, a Treasury of Budget and Finance Commission, hereafter, the Olmec Commission; the Olmec Commission shall possess the sovereignty, jurisdiction and fiscal power superior to that of any Nation, State, Country or government existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; the Olmec Commission headquarters shall be located at the seat of government of the Olmec State;
2. The fiscal power of this Sovereign State is vested exclusively in the Olmec Commission which shall be divided into the Olmec Ambassador, Olmec President, three Chief Financial Officers, Executive Treasury Accountants, and three Trustees; administrative functions shall be performed by the Olmec State Employees;
3. The Olmec Commission shall maintain a general purpose fund for internal operating expenses; a special purpose fund for disaster and economic relief; a capital outlay fund for real estate, commercial enterprises and securities investments; an education fund for construction and building renovations, equipment, supplies, and scholarships; a community relief fund for homeless shelters, food banks, clothing banks, prisoner reentry programs, and parks and recreation equipment and supplies; a health care fund for maintaining hospitals, physician treatment centers, medical equipment and supplies, medications, and birth and burial expenses; and trust instruments that maintain funds and property under the territorial property and jurisdiction of the indigenous peoples of the Americas and the Olmec State for the security, protection and benefit of the Olmec State;
4. The Olmec Ambassador shall possess the supreme authority to govern all internal financial transactions and institutions of the indigenous peoples of the Americas and the Olmec State;
5. The Olmec President shall possess the supreme authority to govern all external financial transactions and appropriate public funds from all Nations, States, Countries, governments and its citizens, organs of society, corporations, organizations, groups, peoples or persons operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State for the annual budget and special purposes of the Olmec State for each ensuing fiscal period, and may submit amendments therefrom to meet deficiencies in the annual budget or special purposes, as determined by the Olmec President; the Olmec President may delegate this authority by executive order to the Vice President and/or Olmec Commission for specific fiscal periods within one annual term;
6. The Olmec President and CFO's shall possess the supreme authority to command and instruct the treasurer of any Nation, State, Country, government and its citizens, organ of society, corporation, organization, group, people or person operating within the territorial property, land and jurisdiction of the Indigenous Peoples of the Americas and the Olmec State by command, taxation, procurement instruction, or appropriation bill; each command, tax, procurement or appropriation bill shall set forth a sum certain amount of currency or monies to be made payable to the Olmec State; and shall maintain all funds within the Olmec State; and shall appropriate operating funds to each office of the Olmec State;
7. The Olmec Commission Chief Financial Officers, hereafter, the CFO's, is responsible for the overall budget development process; financial management and operations; accounting process; account structuring to record revenues, expenditures, assets, and liabilities; development of commerce, exchange, banks and banking, patents and copyrights, and agricultural regulations; issuance of titles, deeds, bonds, securities, certificates, licences and registrations; and finance processing; the CFO's shall monitor and maintain all Olmec State fiscal operations and report to the Olmec President on all fiscal financial matters; and shall directly supervise and administer specific functions to the Olmec Executive Treasury Accountants and Trustees;

8. The Olmec Commission Executive Treasury Accountants, hereafter, the Olmec Accountants, shall be responsible for structuring and maintaining the economic development of the Olmec State; maintaining the financial records of all political subdivisions and proprietary commercial enterprises owned or partly owned by the Olmec State; maintaining all land, real estate instruments and documents and maintenance of property attached to land within the territorial property and land of the Indigenous Peoples of the Americas and the Olmec State; issuance and distribution of trust funds, compensation, and expenses of the Olmec State; monitoring and auditing any Nation, State, Country, government or its citizens, organ of society, corporation, organization, group, people or person operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and establishing rules, regulations and operating procedures regarding commercial transactions, commerce, resources, commodities, currency, securities, banks and banking, patents and copyrights, agriculture, titles, deeds, certificates, bonds, securities, licences, registrations, and generally accepted accounting principles to be followed within the jurisdiction and venue of the Olmec State;
9. The Olmec Commission Trustees, hereafter, the Trustees, shall possess the supreme authority and sovereign political power to retain the Trust Property of the Olmec State and to establish, create, issue, hold, maintain and control trust and subtrust instruments such as: active trust, annuity trust, blended trust, bond trust, charitable trust, common-law trust, Crummey trust, custodial trust, destructible trust, donative trust, dry trust, educational trust, executed trust, express trust, family-pot trust, family trust, foreign-situs trust, generation-skipping trust, grantor-retained annuity trust, grantor-retained unitrust, indestructible trust, insurance trust, inter vivos trust, investment trust, irrevocable trust, land trust, life-insurance trust, mandatory trust, mixed trust, nominee trust, nongrantor-owner trust, oral trust, pension trust, perpetual trust, power-of-appointment trust, private trust, protective trust, real-estate investment trust, resulting trust, revocable trust, self-settled trust, semi-secret trust, spendthrift trust, sprinkle trust, standby trust, supplemental-needs trust, testamentary trust, Totten trust, trust for support, unit-investment trust, and common-law/business trust for the security and benefit of the Assembly of the Olmec State; the trustees shall hold in a subtrust of the Trust, those assets that are to be distributed to the beneficiaries and each subtrust instrument may be identified by adding the name of a beneficiary to the Trust;
10. The Olmec Trustees shall distribute, in convenient installments to or for the benefit of a beneficiary, payment for their health, welfare, education, maintenance and support of the beneficiary. Education includes, but is not limited to, private elementary school, college, graduate school, vocational studies, educational materials and reasonably related living and traveling expenses;
11. The Olmec Commission CFO's may, with the written consent of the Olmec President, command the assistance of any Nation, State, Country or government and their agencies, departments, offices and officers within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State, of which shall provide the Olmec State with the assistance commanded without any delay.

#### **Article XIV.**

#### **Olmec Commercial Economic Corporation; Jurisdiction; Powers and Duties**

1. There is hereby established within the Olmec State, a Commercial Economic Corporation, hereafter, the Olmec CEC, the Olmec CEC shall possess the sovereignty, jurisdiction and commerce power superior to that of any Nation, State, Country, government or its citizen, organ of society, corporation, organization, group, people or person operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; the Olmec CEC headquarters shall be located at the seat of government of the Olmec State;

2. The commerce power of this Sovereign State is vested exclusively in the Olmec CEC which shall be divided into the Olmec Chairman, three Chief Executive Officers, twelve Chief Operating Officers, and one Director for each proprietary business enterprise; administrative functions shall be performed by Olmec State employees;
3. The Olmec Chairman shall possess the supreme authority, commerce power and sovereign political power to issue a business enterprise certificate of authority for all proprietary business enterprises established for the security, protection, and benefit of the indigenous peoples of the Americas and the Olmec State; upon the issuance of a business enterprise certificate of authority to a business enterprise, the business enterprise may engage in any commercial transactions or businesses within the territorial property, land and under the jurisdiction of the indigenous peoples of the Americas and the Olmec State, unless the privilege is suspended or revoked by the Olmec Chairman; the Olmec Chairman shall make sure that all profits generated and received by the Olmec CEC be transferred to the general operating fund of the Olmec Commission;
4. The Olmec CEC Chief Executive Officers, hereafter, the CEO's, shall possess the sovereign political power and commerce power to create rules and regulations regarding all business and commercial transaction requirements, fees and cost of the Olmec State; the development of titles, business enterprise certificates of authority, certificates, licenses and registrations; the development of business enterprise plans, contracts and agreements; and the development and maintenance of all business enterprise commercial real estate; the CEO's shall monitor all CEC proprietary business enterprises and beneficial interest in any such proprietary business enterprises and the Directors to ensure compliance with Olmec State rules and regulations, but shall report to the Olmec President and Olmec Chairman on all substantive proprietary business transactions; and directly supervise and administer specific functions to the Chief Operating Officers and CEC Directors;
5. The Olmec CEC Chief Operating Officers, hereafter, the COO's, shall possess the sovereign political power and commerce power to develop hiring guidelines and procedures; hiring all Olmec State employees and CEC Directors; implementation of contracts and agreements, business enterprise plans, real estate development, construction and maintenance, and keeping and storing all commercial contracts, titles, deeds, certificates, licenses, registrations and employment records; the COO's shall monitor all contractors, employees and CEC Directors for performance evaluation and to ensure compliance with Olmec State rules and regulations, but shall report to the Olmec Ambassador, Olmec President, Olmec Chairman and directly to the CEO's on all substantive commercial and proprietary business enterprise matters and human resource matters of the Olmec State; and shall directly supervise and administer specific human resource guidelines and operating procedures to the CEC Directors and proprietary business enterprise owners;
6. The CEC Directors of proprietary business enterprises, hereafter, the Directors, are responsible for the implementation of business enterprise plans, contracts and agreements, recordkeeping, marketing and promotions, maintaining personnel, maintaining all products and services, maintaining commercial real estate interest, and maintaining health and safety standards; The Directors shall directly supervise all proprietary business ventures under the jurisdiction of the Olmec State and monitor and maintain employee and contract records for performance evaluations, and to report directly to the COO's, CEO's and Olmec Chairman on all substantive commercial and proprietary business enterprise matters;
7. The CEO's and COO's may, with the written approval of the Olmec Chairman, command the assistance of any Nation, State, Country, government or its officers, organ of society, corporation, group or person within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and they shall provide the assistance commanded without delay.

**Article XV.**  
**Miscellaneous**

1. The Olmec State shall perpetually retain and maintain all the supreme authority, sovereignty, sovereign political power, autonomy, titles, rights, fundamental freedoms, independence, jurisdiction, venue, territorial property and land which has been vested within this Constitution and Laws;
2. The Olmec State shall not ever delegate its supreme authority to, be represented by, nor be placed within the realm or jurisdiction of any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person or construct of law created except expressly by the Assembly of the Olmec State; nor shall it be party to any legal instrument created by any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person or construct of law in existence except expressly by the Olmec Ambassador by referendum of the Assembly of the Olmec State;
3. The indigenous peoples of the Americas and the Olmec State, hereby, offer to enter into a firm league of friendship with the United Nations and its members; the Organization of American States and its Member Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property and jurisdiction of the indigenous peoples of the Americas and the Olmec State; the Assembly of the American Continent and its Member Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property of the indigenous peoples of the Americas and the Olmec State; and to provide for the common defenses, security and protection of our liberties and our mutual and general welfare, or for any other pretense the Olmec President may deem necessary;
4. The Olmec State may give full faith and credit to the public acts, records and judicial proceedings of the United Nations and the Organization of American States or the Assembly of the American Continent and its Member Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples or persons operating within the territorial property and jurisdiction of the indigenous peoples of the Americas and the Olmec State which shall not be inconsistent with or contrary to any supreme legislation, rule or regulation established by the Olmec State; but these Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons shall give the Olmec State full faith and credit to their supreme legislations, commands, public and private acts, records, orders, and legislative and judicial proceedings;
5. This Constitution and Laws and any other supreme legislations, titles, rules and regulations which shall be made in pursuance thereof, and all treaties made, or which shall be made, under the supreme authority of the Assembly of the Olmec State, shall be understood and due, as the supreme law of the land within the territorial property and jurisdiction of the indigenous peoples of the Americas and the Olmec State; and all Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property and jurisdiction of the indigenous peoples of the Americas and the Olmec State shall be perpetually bound to observe, respect and obey thereby;
6. The Olmec State shall perpetually retain and maintain the title, patent, common-law copyright and copyright ownership in this Constitution and Laws and all rights, titles, ownership and interest in the property described within this Constitution and Laws;
7. The indigenous peoples of the Americas and the Olmec State shall not be laid or levied any tax, nor pay, be held responsible or liable for any debts incurred by any of the Nations, States, governments or its citizens, organs of society, corporations, organizations, groups, peoples or persons existing and occupying the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;

8. All treaties, agreements by operation of law, legislation, writs, actions, proceedings, civil or criminal liabilities, prosecutions, judgments, sentences, orders, decrees, decisions, appeals, causes of action, contracts, agreements, arrangements, claims and demands made against any participant in this Constitution and Laws of the Olmec State on or before the effective date of this Constitution and Laws, shall be void ab initio, an absolute nullity, repealed, annulled, expunged, and stricken from public record of all Nations, States, governments, organs of society, corporations, organizations, groups, peoples and persons existing, occupying and operating within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State;
9. The Olmec Ambassador may, by written Olmec State memoranda, delegate to any beneficiary, officer, employee, volunteer, or contractor acting under the jurisdiction of the Olmec State, a duty or power of the Olmec Ambassador, and the beneficiary, officer, employee, volunteer, or contractor to whom the duty or power is delegated shall perform the duty or exercise the power at the time and to the extent that the duty or power is delegated by the Olmec Ambassador;
10. The Olmec Ambassador shall possess the sovereign political power to amend, revise, rescind and control any supreme legislation, rule or regulation enacted by the Olmec State as law;
11. The Olmec Ambassador and Olmec CEC shall possess the sovereign political power in the appropriation of privately owned or occupied property within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State, and may, convert such property or land to the Olmec State for its use, control and benefit, in a manner prescribed by the Olmec State;
12. Treason against the indigenous peoples of the Americas and the Olmec State shall consist of any act aimed at the destruction of its beneficiaries, constituent members, citizens, officers, contractors, employees, volunteers, property, rights, fundamental freedoms and laws; levying war against its beneficiaries, constituent members, citizens, officers, contractors, employees, volunteers, property, rights, fundamental freedoms and laws shall result in the prosecution of treason; and adhering to its enemies, giving them aid, comfort or assistance shall also result in prosecution of treason;
13. The Treasurer of all Nations, States, governments, organs of society, corporations, organizations, groups, peoples and persons operating within the territorial property of the indigenous peoples of the Americas and the Olmec State shall determine and authorize with their respective inter-governmental departments, the most efficient and expeditious manner possible for completing all financial transactions and records necessary to implement compensation to the indigenous peoples of the Americas and the Olmec State when commanded;
14. Nothing within this Constitution and Laws may be interpreted as providing implication that any Nation, State, government or its citizens, organ of society, corporation, organization, group, people, person or construct of law existing within the territorial property of the indigenous peoples of the Americas and the Olmec State the right to engage in any activity or to perform any act aimed at the destruction of this Constitution and Laws, the indigenous peoples of the Americas or the Assembly of the Olmec State;
15. In the just preservation of this Constitution and Laws, it shall be hereby understood and due by all Nations, States, governments and its citizens, organs of society, corporations, organizations, groups, peoples and persons existing within the territorial property, land and jurisdiction of the indigenous peoples of the Americas and the Olmec State, that no law, public act, rule, regulation, or procedure ought ever to be established, enacted, have force, negatively affect, be inconsistent with, be contrary to, subvert from or interfere with, in any manner whatsoever, in whole or in part, with this Constitution and Laws; that which does, in whole or in part, negatively affect, are inconsistent with, are contrary to, subvert from or interfere with this Constitution and Laws, are hereby declared an absolute nullity, void ab initio, and repealed, in whole or in part;
16. No principal, interest in the principal or income of any trust or subtrust created under this Constitution and Laws may be anticipated, assigned, encumbered or subjected to a creditor's claims or legal process; this spendthrift provision constitutes one of the material purposes of the subtrust created hereunder;

17. The trustees may make distributions of a minor's trust share, up to the whole thereof, to the guardian of the minor's person or a custodian for the minor under Olmec State regulations, or may apply distributions directly for the minor's benefit;
  18. Each trustee of a trust or subtrust created under this Constitution and Laws, may serve without bond;
  19. This Constitution and Laws shall be construed and enforced in accordance with the Law of Nations and ratify the United Nations Declaration on the Rights of Indigenous Peoples, United Nations Universal Declaration of Human Rights and the Organization of the American States American Declaration on the Rights of Indigenous Peoples;
  20. Despite any other provision of this Constitution and Laws to the contrary, this instrument shall remain perpetual;
  21. Should the Assembly of the Olmec State dissolve its organization, all assets shall be distributed to the indigenous peoples of the Americas who are a party to this Constitution and Laws.

When several persons, at different times and in various places, maintain the same thing as certain, such coincidence of sentiment must be attributed to some general cause. Therefore, I believe that in my capacity as a human being and the indigenous peoples of the Americas; I choose to exercise my self-determination to change my status, body politic and polity; and declare that my status be maintained as a Citizen in the Olmec Office of Sovereign Political Power Holders as my nationality; and that my God, human rights, indigenous rights, inalienable rights, fundamental freedoms and natural laws are inherent in me and that I exist to function as both spirit and human being.

### Article III.

#### Ratification Clause

I, Corey Alan Askeu, in my capacity as the indigenous peoples of the Americas and status as a Citizen in the Olmec Office of Sovereign Political Power Holders do hereby acknowledge, recognize, confirm, agree accept and consent to the following Constitution and treaties, and declare that it is my manifestation of intention to become a party to and legally attach myself to them, to wit:

- A. Olmec Office of Sovereign Political Power Holders, Constitution and Laws;
- B. Charter of the United Nations and Statute of The International Court of Justice;
- C. United Nations, Universal Declaration of Human Rights;
- D. United Nations, Declaration on the Rights of Indigenous Peoples;
- E. United Nations, International Covenant on Civil and Political Rights;
- F. United Nations, International Covenant on Economic, Social and Cultural Rights;
- G. Charter of the Organization of the Organization of American States; and
- H. Organization of American States, American Declaration on the Rights of Indigenous Peoples.

### Article IV.

#### Pledge of Allegiance

I, Corey Alan Askeu, hold these truths to be self-evident, that all human beings are created equal, that they are endowed by their Supreme Being with certain natural rights, inalienable rights and fundamental freedoms; that among these rights and fundamental freedoms are the rights of Life, Liberty, Property, and the Pursuit of Happiness. To pursue these rights and fundamental freedoms, governments are instituted by men and women, deriving their delegated powers from the consent of the governed. That whenever any form of the government becomes destructive of these ends, it is the right of the people to alter or abolish it, and to institute a new form of government, laying its foundation on such principles and organizing its powers and duties in such form, as to them shall seem most likely to affect their safety and happiness. Accordingly, all my experience and observance have shown, that certain melanin copper colored human beings indigenous to the Americas are more disposed to suffer, while evils are sufferable, than to right themselves by altering or abolishing the forms of government to which they were forcefully assimilated under the ownership and citizenship of the United States of America and/or United States and State governments thereof.

Therefore, I, Corey Alan Askeu, must acquiesce in the necessity of my perpetual separation from the government instituted by the people of the United States of America and The State of Michigan, as being a citizen under their political power and jurisdiction; and hereby recognize each as subordinate political powers and institutions to my capacity, status and sovereign political power in the indigenous peoples of the Americas. I Am, and of right ought to be, one individual of the indigenous peoples of the Americas; that, I Am hereby absolved from any allegiance, obligation or duty to any Nation, State, government or its citizenship, organization, organ of society, corporation, people or person that are members of the Organization of American States and the United Nations existing in the American Continent; and that all political connection between us is perpetually altered. It is my manifestation of intention to change my polity and pledge my allegiance to the Assembly of the Olmec Office of Sovereign Political Power Holders (Olmec State) and exercise my right of self-determination to transfer my political power to the Olmec Office of Sovereign Political Power Holders to exercise as my representatives.

I, Corey Alan Askew, accept, agree and consent to the responsibilities, obligations and duties of the Office of Citizenship within the Olmec Office of Sovereign Political Power Holders; and do solemnly affirm that I will support, respect, observe and abide by (a) the Olmec Office of Sovereign Political Power Holders Constitution and Laws; (b) all rules, regulations, orders, commands and supreme legislations enacted by the Olmec Office of Sovereign Political Power Holders; (c) the Law of Nations; (d) the United Nations Charter; (e) the United Nations Universal Declaration of Human Rights; (f) the United Nations Declaration on the Rights of Indigenous Peoples; and (g) the Organization of American States American Declaration on the Rights of Indigenous Peoples; and that I will faithfully discharge the duties and functions of the Office of Citizenship, discreetly and in secrecy according to the best of my ability; So Be It, bona fide.

**Article V.  
Authentication**

I, Corey Alan Askew, in my capacity and status as one individual of the indigenous peoples of the Americas, the sovereignty, do hereby affirm, authenticate, publish and give immediate effect to this pledge of allegiance to the Olmec Office of Sovereign Political Power Holders; bona fide.

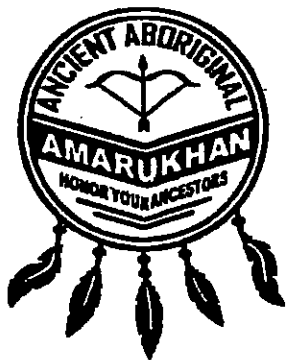

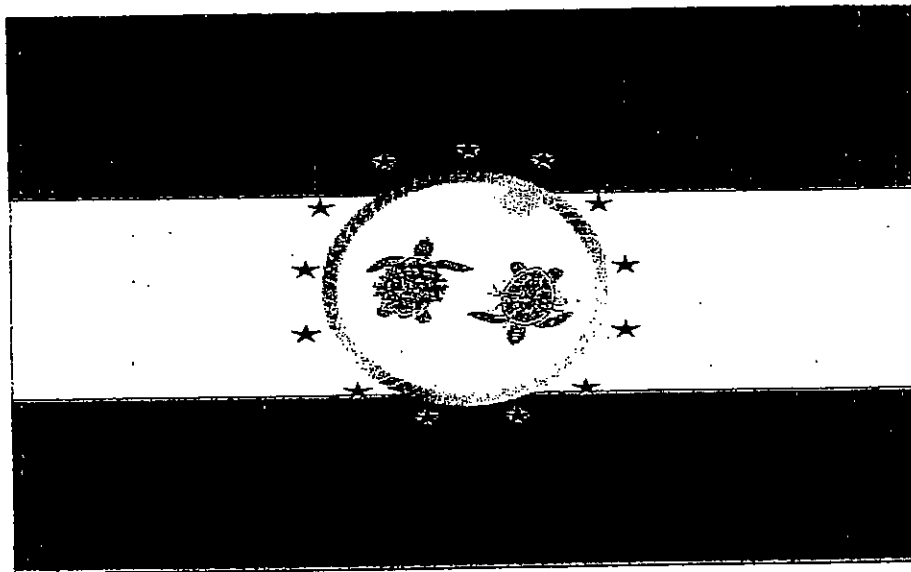



We enter into a firm league of international relations as a peace-loving independent American State with the Organization of American States and request Membership in the Organization of American States and to become a Party to the following Conventions in order to exercise our right to self-identification, self-determination, Human Rights, economic development, social development and cultural development in the international plane and the American Continent; to wit:

1. Accession of the Organization of American States Convention on Rights and Duties of States;
2. Ratification of the Organization of American States American Convention on Human Rights;
3. Ratification of the Organization of American States Additional Protocol to the American Convention on Human Rights in the Field of Economic, Social and Cultural Rights "Protocol of San Salvador";
4. Ratification of the Organization of American States Inter-American Convention on General Rules of Private International Law;
5. Ratification of the Organization of American States Inter-American Convention on Domicile of Natural Persons in Private International Law;
6. Ratification of the Organization of American States Inter-American Convention on the Rights of the Author in Literacy, Scientific and Artistic Works;
7. Ratification of the Organization of American States Inter-American Convention Against Terrorism; and
8. Ratification of the Organization of American States Inter-American Development Bank Articles of Agreement.

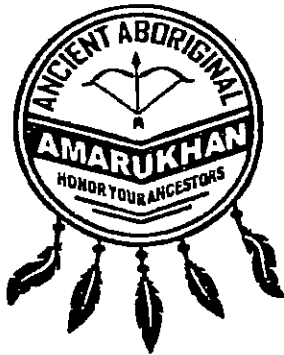

## Note to the Secretary General

Pursuant to the Charter of the Organization of American States, Article 6, we the indigenous peoples of the Americas, assembled as one body politic within the Olmec Office of Sovereign Political Power Holders, do hereby give notice to the Secretary General of the Organization of American States that we declare that we are willing to sign and ratify the Charter of the Organization of American States and accept all the obligations of an independent American State inherent in this membership.

It is our manifestation of intention that we enter into this social compact with the Organization of American States to be recognized as an independent American State and as an international person having a legal personality in international law so that we can exercise our inalienable right to self-identification, self-determination, human rights, economic development, social development and cultural development on the international plane and within our territorial property and jurisdiction within the American Continent.

BE IT RESOLVED, that the Assembly of the Olmec Office of Sovereign Political Power Holders is an independent American State and hereby declare and establish its status as the indigenous peoples of the Americas; and request that the Secretary General of the Organization of American States deposit this note and serve proper international notice to the Member States of the Organization of American States, the United Nations and the other political subdivisions thereof that the Olmec Office of Sovereign Political Power Holders (Olmec State) are to be recognized as an independent American State.

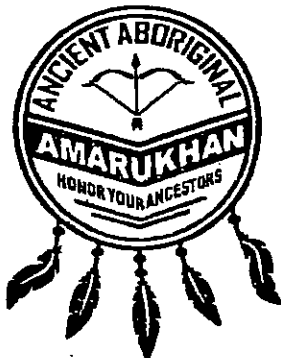
