ORDER

Before the Court is a Report and Recommendation (R&R) on Sedrick D. Russell's habeas petition. Docket No. 14. Russell, acting *pro se*, has objected to the R&R's proposed disposition of his case. Docket No. 15.

A review of the petition indicates that the issues it presents are significant not just to Mr. Russell, but to the very functioning of a minimally-adequate criminal justice system. *See, e.g., Patterson v. Hinds Cty., Mississippi*, No. 3:13-CV-432, 2016 WL 7177762 (S.D. Miss. June 10, 2016) (describing speedy trial challenges in Mississippi). Accordingly, the undersigned finds that the interests of justice require appointment of counsel. Attorney Alysson L. Mills is hereby appointed to represent Russell in this proceeding. *See* 18 U.S.C. § 3006A(a)(2); 28 U.S.C. § 2254(h). The record indicates that Russell is financially eligible for appointed counsel. *See* Docket No. 2.

A copy of this Order will be emailed to Mills, who shall timely file her entry of appearance. An amended objection to the R&R is due by July 26, 2017.
