## PETITION FOR REHEARING

Petitioner Joseph Gilberti P.E., an individual and professional licensed Engineer petitions for rehearing of this Court's October 30, 2023 order denying the petition for a writ of certiorari. As noted in the Order, Chief Justice John G. Roberts, Jr., Associate Justice Sonia Sotomayor, Associate Justice Clarence Thomas, Associate Justice Samuel A. Alito, Jr., and Associate Justice Elena Kagan, Associate Justice Amy Coney Barrett, Associate Justice Neil M. Gorsuch and Associate Justice Brett M. Kavanaugh would have granted the petition.

## REASON FOR GRANTING REHEARING

This Court's Rule 44.2 authorizes a petition for rehearing based on "intervening circumstances of a substantial . . . effect." Petitioner has found knowledge and is verified by Congress on Primary Water access that STOPS WARS IN MIDDLE EAST and across EARTH with ENDLESS FOOD AND ENERGY PRODUCTION FROM DEEP UNDERGROUND HIDDEN RESOURCES hidden by the INDUSTRIAL MILITARY COMPLEX out of Tampa Central Command!

**(IV) CRIMES OF GENOCIDE/EUGENICS**

*General Assembly resolution 260 A(III) of 9 December 1948 Entry into force: 12 January 1951, in accordance with article XIII*

Having considered the declaration made by the General Assembly of the United Nations in its resolution 96 (I) dated 11 December 1946 that genocide is a crime under international law, contrary to the spirit and aims of the United Nations and condemned by the civilized world, Recognizing that at all periods of history genocide has inflicted great losses on humanity, and being convinced

that, in order to liberate mankind from such an odious scourge, international co-operation is required, Hereby agree as hereinafter provided:

**Article I**

The Contracting Parties confirm that genocide, whether committed in time of peace or in time of war, is a crime under international law, which they undertake to prevent and to punish.

**Article II**

In the present Convention, genocide means any of the following acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group, as such:

- (a) Killing members of the group;
- (b) Causing serious bodily or mental harm to members of the group;
- (c) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part;
- (d) Imposing measures intended to prevent births within the group;
- (e) Forcibly transferring children of the group to another group.

**Article III**

The following acts shall be punishable:

- (a) Genocide;
- (b) Conspiracy to commit genocide;
- (c) Direct and public incitement to commit genocide;
- (d) Attempt to commit genocide;
- (e) Complicity in genocide.

**VII. Gilberti vs George Bush, Dick Cheney, Sarasota County for 9-11 connection is filed in DC and New York with letters to all US Attorney Generals in each State to arrest Leaders and media for Title 18 US Code 241-242.**
