**PETITIONER'S MOTION AND AFFIRMATION FOR
LEAVE TO PROCEED IN FORMA PAUPERIS**

Petitioner, Brent Brewer, through counsel, respectfully moves for leave to proceed *in forma pauperis* and submits as follows:

1. This case is before the Court on a petition for writ of certiorari.
2. Brent Brewer is a death sentenced prisoner in Texas.
3. On February 26, 2015, the United States District Court for the Northern District of Texas appointed counsel to represent Petitioner in this capital habeas proceeding but required him to pay the \$5 filing fee. A copy of that Order is attached.
4. On March 28, 2016, the district court issued an order appointing the office of the Federal Community Defender for the Eastern District of Pennsylvania, with whom undersigned counsel are employed, as co-counsel for Mr. Brewer. A copy of that Order is attached.

5. On May 11, 2022, the Fifth Circuit docketed his appeal and allowed him to proceed *in forma pauperis*, and appointed counsel. A copy of the docket sheet is attached.

6. Petitioner remains incarcerated today and there has been no change in his financial status. He is without funds to secure the services necessary to proceed in this Court (*e.g.*, printing fees, etc.) or to pay any fees.

7. Undersigned counsel affirms that all statements related above are true and correct.

WHEREFORE, Petitioner requests that this Court allow him to proceed *in forma pauperis*.



ORDER CONDITIONALLY APPOINTING COUNSEL

On February 3, 2015, **Brent Ray Brewer** (“Petitioner”) filed a motion for appointment of counsel (“Motion,” ECF No. 1). Having reviewed the motion, the Court finds that Petitioner is entitled to the appointment of counsel by the provisions of 18 U.S.C. § 3599(a)(2). *See McFarland v. Scott*, 512 U.S. 849, 855-58 (1994). The Court further finds that attorney **Michael B. Charlton** possesses the background, knowledge, and experience to enable him to represent Petitioner with due consideration to the seriousness of the possible penalty and the unique and complex nature of the litigation, and is qualified and willing to accept this appointment as lead counsel. The Court further finds that Michael B. Charlton has requested the appointment of **Philip Alan Wischkaemper** as co-counsel to assist lead counsel in the representation of the petitioner in these proceedings, and that the said Philip Alan Wischkaemper is qualified and willing to accept this appointment as co-counsel.

Petitioner, however, has not paid the \$5 filing fee and has not filed an application to proceed *in forma pauperis* (“IFP”) in accordance with local rules.¹ *See* LR 83.6; Misc. Order 13 at ¶ 9

¹The Motion references a “declaration of indigency” and “certified statement of Petitioner’s inmate trust account,” but none were filed. (Mot. at 3.)

(N.D.Tex. Feb. 1, 1977). Therefore, this appointment of counsel is conditioned upon the payment of the \$5 filing fee or the filing of an appropriate motion to proceed IFP within 60 days of the date of this order.

Petitioner's motion for appointment of counsel (ECF No. 1) is conditionally **GRANTED**, attorney **Michael B. Charlton** is appointed as lead counsel to represent Petitioner in this cause, and attorney **Philip Alan Wischkaemper** is appointed as co-counsel to assist lead counsel in this cause; provided however that Petitioner shall satisfy the filing-fee requirement within **60 days** of the date of this order or this proceeding shall be terminated and the appointment of counsel herein rendered null and void.²

Subject to the satisfaction of the filing-fee requirement set out above, appointed counsel are entitled to compensation (currently at the rate of \$181.00/hour) in accordance with Volume VII, Part A, Chapter 6, of the *Guide to Judiciary Policy*, which Counsel is directed to read along with the instructions for forms CJA 30 and CJA 31 in order to ensure proper compensation for time and expenses incurred herein, and the presumptive limits contained in the *Special Procedures for Reviewing Attorney Compensation Requests in Death Penalty Cases* by the Judicial Council of the Fifth Circuit. Counsel are also advised of the requirement of pre-approval for the use of associate counsel under the Criminal Justice Act (CJA) plan adopted by this district.³ Counsel shall be entitled to interim payments for services rendered in this cause.

²This does not prevent the Court from extending this deadline upon a proper motion.

³The CJA plan provides that "An appointed counsel may not claim compensation for services furnished by a partner or associate, or counsel who is not a partner or associate, without prior authorization by the court." See Misc. Order 3 at VIII(B) (N.D.Tex. Sep. 15, 2000).
