08/10/2020	110	Minute Entry for proceedings held before Judge Silvia L. Carreno-Coll: Competency Hearing as to Adam Strege (1) held on 8/10/2020 by Video Telephone Conference (VTC). Present were AUSA Vanessa Bonano and AFPD Victor Gonzalez. The defendant was under custody, present in court by VTC and did not require the services of the Court Interpreter. The findings under the CARES Act should reflect that given the exigent circumstances created by the COVID pandemic and the Declaration of Emergency by the State and Federal Government, this hearing is being conducted by VTC in order to ensure the rights of the defendant, his eligibility for programs subsequent to sentencing, which will turn to his benefit, and the health of all the parties involved. Sworn testimony of expert witness Dr. Lisa Feldman was heard on behalf of the United States. Direct and cross-examination were conducted. Defendant was heard. After having heard the parties, the Court declared the defendant incompetent to stand trial. Defense counsel requested that the Complaint be dismissed. The Government agrees with the court's finding, however requested that if the case is going to be dismissed that the defendant goes under a restoration period. Defense counsel opposed. Matter of defendant's restoration period held under advisement. Order to be entered. (Court Reporter Zulma Ruiz.) Hearing set for 10:30. Hearing held at 10:44. Hearing ended at 12:05. 
