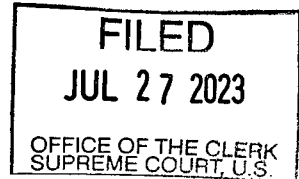

NOTICE OF MOTION TO PROCEED INFORMA PAUPERIS
AND FOR ASSIGNMENT OF COUNSEL

3. Mr. Decker was again granted informa pauperis status in the filing of the Notice of Appeal, see docket number: 52, of the same case no. 2:21-cv-00253-JPH-MJD and Seventh Circuit docket number: 22-2475.

4. Mr. Decker's financial status has not changed and he is still unable to pay any filing fee that may be associated with this case.

5. Mr. Decker does not own anything worth any tangible value and he does not own any cars, property, bank accounts, stocks, jewelry, or anything that may be worth anything.



ORDER GRANTING MOTIONS TO PROCEED ON APPEAL *IN FORMA PAUPERIS*

The plaintiff's motions for leave to proceed *in forma pauperis*, dkt. [44] and dkt. [50], are **granted**. The plaintiff's trust account information reflects that he lacks sufficient funds to pay an initial partial filing fee. Title 28 U.S.C. § 1915(b)(4) provides that a prisoner shall not be prohibited from appealing a civil judgment "for the reason that the prisoner has no assets and no means by which to pay the initial partial filing fee." Accordingly, no initial partial filing fee is due.

Although the plaintiff is excused from *pre*-paying the full filing fee, he still must pay the five hundred and five (\$505.00) appellate filing fee pursuant to the statutory formula set forth in 28 U.S.C. § 1915(b)(2) when able. *See* 28 U.S.C. § 1915(b)(1) ("the prisoner shall be required to pay the full amount of a filing fee.").
