## GROUNDS

Petitioner respectfully requests a rehearing of the Petition for a Writ of Certiorari on the grounds of an omission. The Petitioner's Reply Brief dated October 27, 2023, submitted in response to the Brief of McNess, Wallace and Nurick, LLC, was not filed by this Court (See Appendix A). The Petitioner notified this Court of the omission on or about November 6, 2023 (See Appendix B). However, the reply brief was not distributed by this Court for review during its consideration of the Petitioner's writ.

This Court in 601 U.S. 23-13 (2023) stated *"...part of our deep-rooted historic tradition that everyone should have his own day in court."* Richards vs Jefferson County, 517 U.S. 793, 798 (1996). The appeals court of Pennsylvania by upholding the lower court's violation of the Petitioner's right to trial by jury conflicts with this Court's *"deep-rooted historic tradition that everyone should have his own day in court"* and *"The right of trial by jury as declared by the Seventh Amendment to the Constitution or as given by a statute of the United States shall be preserved to the parties inviolate"*.
