



## STATEMENT OF THE CASE

On November 28, 2017 I was working my normal shift at the Walmart Neighborhood Fuel Station 820 E. Belt liner Rd in Cedar Hill, Texas, 75104. When the store manager Daniel Asebcio came over to clean the outside, with the assistance of the then Fuel Station Manager Nadia. I was working with the customers on the inside. When Nadia came into the inside to get a mop, for the outside. She carried the mop outside without the mop bucket. I walked over the front of the counter to assist a customer. After assisting the customer, I started walking back behind the counter. Where I then stated slipping down behind the counter, where I hit the concrete floor. Which caused the injury to my lower back and my right arm rotator cuff tear. I went to the emergency room on November 30, 2017. Since then I have had surgery on my right arm rotator cuff repaired with screws as well as surgery on my lower back L5-S1. I am still under the doctor, for my lower back as well as on medications and having to have steroid injections in my back for chronic pain.


## **REASON FOR GRANTING THE PETITION**
