
No motion for rehearing or reinstatement will be entertained by the Court.


**ORDER STRIKING DEFENDANT'S PRO SE "MOTION TO SUBPOENA JAIL'S
VIDEO VISIT"**

THIS MATTER came before the Court upon Defendant's *pro se* "Motion to Subpoena Jail's Video Visit" filed on June 14, 2023. The Court having reviewed the motion, the court file, and being otherwise fully advised in the premises, hereby finds:

The Office of the Public Defender currently represents Defendant. There is "no Sixth Amendment right to simultaneously proceed *pro se* and with legal representation." *Sheppard v. State*, 17 So. 3d 275, 279 (Fla. 2009). Therefore, because Defendant had counsel at the time his *pro se* motion was filed, it is a legal nullity.

Accordingly, it is hereby **ORDERED AND ADJUDGED** that Defendant's *pro se* "Motion to Subpoena Jail's Video Visit" is **STRICKEN**.
