Count 1: MISDEMEANOR BATTERY

The above-named defendant on or about Monday, June 8, 2020, in the City of Eau Claire, Eau Claire County, Wisconsin, did cause bodily harm to TD, by an act done with intent to cause bodily harm to that person or another, without that person's consent and with the knowledge that the person so harmed did not consent, contrary to sec. 940.19(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 2: DISORDERLY CONDUCT

The above-named defendant on or about Monday, June 8, 2020, in the City of Eau Claire, Eau Claire County, Wisconsin, while in a private place, did engage in violent conduct, under circumstances in which such conduct tended to cause a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.
