

On March 21, 2007, a jury found Defendant guilty of two class 1 felonies: one count of first-degree murder and one count of conspiracy to commit first-degree murder. Defendant was 16 years old at the time of the offenses. The Court entered judgment and sentenced Defendant on May 4, 2007 to a natural life sentence without the possibility of "parole" on Count 1, and a concurrent life sentence with the possibility of "parole" on Count 2. Thereafter, this Court dismissed Defendant's first two Rule 32 proceedings in Orders filed on May 24, 2011 and July 18, 2013, respectively. The Court also denied relief after a full round of briefing in a third proceeding seeking Rule 32.1(g) relief based upon *Miller v. Alabama*, 567 U.S. 460 (2012) in an order filed on May 14, 2014. However, that claim was reconsidered. On March 21, 2017 counsel was appointed to explore his Rule 32.1(g) relief based on his juvenile status at the time of sentencing. Defendant is pending resentencing after appeal (7/20/16 2-CA-CR 2016-0201). On 1/25/17, after the appeal but prior to the mandate, defendant, through counsel, filed a PCR. On May 19, 2017 Defendant, through counsel Mr. Stavris, filed a motion to stay that PCR pending sentencing. Pam Nicholson was appointed to represent Defendant in September 2017.

This Court denied defendant's pro per 7/20/21 PCR filing because he is represented by counsel, Defendant filed a motion for reconsideration and an amended Notice Requesting Post-Conviction Relief on 8/7/21. The court has considered the Motion for Reconsideration, Request

to File an Amended Notice Requesting Post-Conviction Relief, the Amended Notice as well as the state's response.

Defendant is raising claims under Rule 32.1(a),(e) and (g) and (h). He alleges he was denied the right to testify, there was prosecutorial misconduct, he was denied a fair and impartial jury and newly discovered evidence exists.

The Court finds defendant fails to provide a valid reason for failing to raise these claims in a timely manner. Defendant further alleges he had new information from a witness's interview from 2018. Defendant fails to explain the delay in seeking the PCR and fails to provide any information as to the nature of the newly discovered evidence.

The Court may summarily dismiss if Defendant fails to "provide sufficient reasons why the defendant did not raise the claim in a previous notice or petition, or in a timely manner". ARCRP Rule 32.2(b). See also Rule 32.4(b)(3).

IT IS ORDERED granting the motion for reconsideration.

IT IS ORDERED granting the Motion requesting permission to file an amended Notice Requesting post-conviction relief.

IT IS ORDERD dismissing Defendant's Amended Notice Requesting Post-conviction relief.

MEMORANDUM DECISION

Presiding Judge Maria Elena Cruz, Judge Angela K. Paton, and Judge Peter B. Swann delivered the decision of the Court.

PER CURIAM:

¶1 Petitioner Joshua Aston seeks review of the superior court's order denying his petition for post-conviction relief. This is petitioner's fourth successive petition.

¶2 Absent an abuse of discretion or error of law, this court will not disturb a superior court's ruling on a petition for post-conviction relief. *State v. Gutierrez*, 229 Ariz. 573, 577, ¶ 19 (2012). It is petitioner's burden to show that the superior court abused its discretion by denying the petition for post-conviction relief. *See State v. Poblete*, 227 Ariz. 537, 538, ¶ 1 (App. 2011) (petitioner has burden of establishing abuse of discretion on review).

¶3 We have reviewed the record in this matter, the superior court's order denying the petition for post-conviction relief, and the petition for review. We find that petitioner has not established an abuse of discretion.

¶4 We grant review and deny relief.
