5 QUESTION(S) PRESENTED

The "all men are created equal" forewords of the U.S. Constitution expect all who works for the American government, every citizen of America, and 100% of democracy followers to side with my lawsuit.

① Did the appeal court err in stating I lacked standing eventhough the "all men are created equal" words of the Preamble of the Declaration of Independence would recognize that the invasion of my legally protected interest is the ^{STOLEN PARTICIPATION} in an all-men-are-created-equal election via an all-men-are-created-equal ^{NEW} voting system that only dispurses 1 voting power per registered voter (No triple or duplicate mailing ballots to same voter, and absolutely no mailing ballots to dead voters).

② Did the appeal court err in stating that I lacked standing even though my injury-in-fact of mental illness (anger, paranoia, and fear) led me to protest against the ^(RESPONDENT, the U.S.A) Defendant by giving and relinquishing my American citizenship to go back to Vietnam is personal (concrete, particularized, and imminent) as a Trump's voter in the new voting system (vote-by-mail) of the 2020 Presidential Election launched hastily during the COVID-19 pandemic to prevent infection at the polls. Furthermore, I clearly stated that the redressability of my lawsuit was a simple letter of apology OR pay \$25,000 for the work of submitting this lawsuit instead of the \$1 trillion dollars or recount-recheck in battleground states.

b.

③ Do I have standing under the product negligence claim when I pointed out to the appeal court that the ^(RESPONDENT / the USA) Defendant's vote-by-mail system is a brand new voting system of America, and currently the ONLY product of America (the greatest form of democracy in humanity)?

I explained to the appeal court that when ^(RESPONDENT, the USA) the Defendant launched this new product, the ^(RESPONDENT, the USA) Defendant was well-informed by media, Trump, and some Congress men & women that the new product had defects that failed ^{to} reflect the "all men are created equal" words of the Preamble. The defects were triple and double voting ballots were sent to the same voter, and voting ballots were sent to some lucky dead voters. The ^{RESPONDENT /} Defendant ignored the defects before and after election by failing to fix the defects with my suggestion of a bandage system of recount-recheck in battlegrounds.

c.

④ Do I have standing under FTCA or Federal Tort Claim Act when the Preamble stated that all men are created equal means it is the duty of the ^{Respondents/}Defendant's employees (from janitors to U.S. Supreme Court judges) to conduct an all-men-are-created-equal ^{ELECTION} using an all-men-are-created-equal new voting system of dispensing only one voting per voter (to only living voters) and only count 1 vote per voter before announcing the winner. Since it was too expensive & late for the

Defendant's employees to prove accountability before the new voting system (vote by mail) was launched,

I suggested to the Defendant's employees via Nancy Pelosi & Mitch McConnell to pause the work on January 6th, 2021 to conduct a recount - recheck in battleground states first.

⑤ This last question is the least important; however, it perplexed me to witness how the appeal court can ignore my claim of product negligence in its decision to shut down my lawsuit. It also perplexed me how the district court was able to convince the appeal court that the product negligence claim & the FTCA (Federal Tort Claim Act) ^{claim} are the same claim under Res judicata argument when the appeal court disagreed with the district court that ^{the} Res judicata argument was wrong to use in dismissing my case. I asked for a rehearing for the appeal court to state its decision on my product negligence claim, but the appeal court said "No."

STATEMENT OF THE CASE

On 2/16/2022, Nguyen (petitioner) or Mai-Chang Thi Nguyen sued the Defendant / Respondent (the USA) with 2 claims (product negligence and Federal Tort Claim Act or FTCA) for its NEW vote-by-mail system which was launched faster than God's speed to prevent the spread of the COVID-19 virus at the poll in choosing Trump or Biden as president of America in the 2020 election. On 7/18/2022, the district court dismissed the case based on the ruling of res judicata, mootness, and lack of standing arguments. On 7/21/2022, Nguyen filed an appeal with the appeal court. On 7/12/2023, the appeal court affirmed the dismissal of Nguyen's case but only under the argument of lack of standing — not mootness & res judicata.

On 7/19/2023, Nguyen filed a motion for reconsideration asking the appeal court for the answer of the ignored claim (product negligence). On 10/11/2023, the appeal court denied the request & closed the case.

I. ARGUMENTS

A. My Standing Under the Preamble of the Declaration

The "Preamble" is the goal of the Constitution signed off by the founding fathers to the King of England arguing that even though the "King" is king, he is still a man. Thus "all men are created equal." Now "all men" are translated to "all humans." All humans are created equal must be the goal of an election in this country so a NEW voting system ^{MUST} reflect that goal. Equal means distributing one vote per voter and collecting one vote per voter. The vote-by-mail system dispensed triple and double mailing ballots

to the ^{SOME} same voters, and it also sent out ballots to ^{SOME} dead voters. I and ^{the} American voters should be able to sue the Defendant if its Vote-by-mail system contradicted with the "Preamble's" goal of the Constitution.

B. My Standing in My Injury In Fact of suing To Release My Mental-illness & Relinquishing My American Citizenship

How would you feel if you were running for class president and your school passed out 2-3 votes to some of your classmates, and only 1 for you. Furthermore, you witnessed a few ballots with names of some dead classmates or students from 2 years ago who ^{ALREADY} graduated out of high school? Do you think you will be injured in the head to develop instant feelings of anger, paranoia, fear, etc.?

Sure some students would develop no injury because they don't care, but there are students who care. The students ^{who ARE} running for office would care the most. I, Mai-Trang Thi Nguyen, was one of those who cared to develop such high emotions in my little brain to quickly ^{ACT} on an impulse to ~~RELEASE~~ MY emotions by ~~SWING~~ (the least violent way to ^{PURSUE} REVENGE). Furthermore, I deepened my protest against the Defendant by relinquishing my beloved American citizenship to go back where I came from (Viet Nam) as an ex refugee of the Vietnam war to certify my firm feelings of the Defendant's wrong doings in their quick launch of humanity's UNPRECEDENTED voting system of vote~~s~~ by-mail in 2020 as a country.

Let's use this next section discussing why I should be able to sue (have standing) by analyzing if my injury is qualified by the law as "concrete, particularized, imminent, and ^{AAAS} causation) — injury-in fact.

Here are the reasons below:

① I mentioned ^{that IT} was the duty of all employees of the ^{RESPONDENT} Defendant (janitors to U.S. Supreme Court justices) to make sure the government conducts an all-men-are-created-equal election with an all-men-are-created-equal NEW voting system (vote-by-mail). I used to be an employee of the government as a substitute teacher and later became a real teacher for 1 whole month after I received my teaching credential. My teaching subject was social studies so I had no choice but to jump in and sue to release my anger that the "all men are created equal" words of the "Preamble" was not followed by the vote-by-mail system in 2020.

② After I quit being a teacher because the job was extremely hard, I worked at yummy ^{SUGARY} Starbucks for the loving health benefits while working part-time in ^A more brainless - and - fun work and still get to exercise my ~~soul~~ body off. While working for Starbucks (very gay loving company) in San Francisco (gay capital of the world), I became a disabled and a mental from a work-related-injury (^{employer-abandoned-}back-strain) in 2008 thanks to the U.S. employment laws (including workers compensation, even perhaps freedom of religion, and definitely sexual harassments and bullying especially by 3-4 gay bosses and 5-7 baristas who were chummy with the gay-bosses gang). To avoid being a homeless crippled & mental, I had to quickly sell my condo for ^{in the recession of 2008} dirt-cheap price and sold all my 401K plan to keep a roof over my ^{body and} crippled head. Fifteen years and a half later, I became a semi-homeless

crippled and mental with my car as my own stable bed or home ^{while} jumping from living in a room here, there, and even in garage. Two years after becoming a disabled with mental illness, I was rewarded with disability checks to rebuild.

When the injury of 2020 occurred (mental illness of My another-human's-RIGHT was robbed & the highest RIGHT in humanity: All-men-are-created-equal right offered by the Preamble of the Declaration of Independence of the Constitution), all the memories of the injury in 2008 came back, and I acted without deep thinking and jumped into another lawsuit to release my anger. (For your information, the 2008 pain led me to sue 2 times which got rejected by the U.S. Supreme Court in cases: 10-1489 and 11-661)

In the last 15.5 years being a crippled & a mental, I witnessed so many of my rights were robbed (even my civil rights to EXERCISE via walking my fat,

depressed, muscle-tightened up body with back pain
on the ^{STREETS} ↓ in GREAT AMERICA). However, to witness
basic right to getting the same voting power as another
human and even some dead humans, I had no choice
but to sue to release my anger because my crippledness
and especially my mental-illness won't allow me to
protest in public anymore especially flying to Capitol Hill
to protest on January 6th, 2021.

I became so angry that I had to choose
the greatest Nonviolent protest of all — Relinquish my RICH
American citizenship to go back to where I belong...
as soon as I pay off all my debt to my adopted
country America & in America. To think that I used
to be a democrat who voted for Obama (with Biden
as his vice president candidate) in 2008, supported
gay marriage and I understood most of their pain even though
I am a hard-core heterosexual female, makes me sad
& disgusted.

(3) I would like to dedicate this section to explain if my injury is "imminent" or has "causation." As a certified social studies teacher who taught American history and world history in high-school level, I had to do research to find out what happened when Capitol Hill was ^{FIRST} raided to compare to the second time Capitol Hill was raided on January 6th, 2021. ^{I LEARNED THAT} the American Civil War occurred 40-50 years after the Capitol building was raided. This was the main & last thing I needed to see before I allowed my 2020-vote-by-mail-system mental-illness of fear & paranoia to take over my rationality as a human to add the words of "I relinquish my American citizenship to go back^{to} where I belong" SINCE I don't want to deal with another civil war (this time in America) when I already dealt with one in Vietnam. If it is true that the Respondent (the USA or defendant) was wrong to ignore the "all men are created equal" words of the Preamble of the

Declaration of Independence in the Constitution package,
and the Respondent is allowed to win my lawsuit while
ignoring its mistake, then hell will meet America
in your children's and grand-children's lifetime just like
hell ^{have} met the children's & grandchildren's lives in
Israel, Palestine, Ukraine, Armenia again, Russian,
Bosnia again (I think), and Sudan. If you adult
won't lower your egos a bit to accept your mistakes
starting with my lawsuit, then I suggest the children
of America who can understand my best-English writing
to stand up to protest & sue using my lawsuit
as ^A reference. Ask your government to pay for the expensive
filing fee. Do this in your advanced government,
American history, and world history classes as side
projects for extra credit ^{to get into colleges}. The word "men" is translated
to humans and children are humans, too.

④ I had personal ties with some of Trump's agendas in 2020 so I had to sue to get him & get ^{HIS} people out of jail. Here are the concrete & particularized items:

a. China poisoned the ^{WATER AND} fish in Northern Vietnam when it acted like a big bully around that time trying to claim some land near its border. I don't know whose land it originally belonged to, but poisoning water and kill the fish is what I hate more.

b. I don't have time to learn Spanish as my 2nd language in America, but I fear for Biden's open border policy ^{BY} allowing massive caravans of poor & innocent Latin Americans marching like troops ^{(SOME} with their countries' flags) to enter America. One day the Constitution of America will be accompanied

with a Spanish version with a new name of
this country as United States of Latin America.
Soon, the children in India and Hong Kong
(China) will rise up to be

the guardians of the English language
as the business language of humanity
because those kids are taught with proper
English as EX-^{COLONIAL}territories of the mother of
the English language - England.

c. Furthermore Biden's policy at the border will
kill the safety of me & its people with the easier
flow of Fetang/^{AND} people who hate & want
to bomb America's school, malls, libraries,
market, playgrounds, etc.

d. I nearly died as a hard-core heterosexual
female as a sexual harassed in a minor,
FORM

by a young lesbian boss (^{NEWEST/LATEST} store manager)
of Muslim descent at Starbucks with her
lesbian breasts ^{GENTLY} brushing against mine 4
times during the first month of her
employment at Starbucks. I was propositioned
to have a baby with a flaming young
handsome GAY LATINO MAN with indigenous-
American ^{- RESERVATION} background. I was asked to
go out to hang out by an older white Jewish
man with direct ties from France & Germany
with hidden intention to use me as a
bait to attract heterosexual men for him
to flirt with.

When I got injured
with a BACK-SPRAINED injury on a festival-work
day at Starbucks, the Jewish assistant-
manager failed to report my back-injury
when I had to remove myself with his

permission to go downstairs to rest my injury and later left work. I was too busy to CARE for every one was stressed out ^{working on}

A festival day during that weekend. However, when I "crawled" back to get my check to pay for rent, he told me ^{that} I was no longer welcomed while I was still legally an employee of Starbucks. The next day I called human resources in San Francisco office & I said "I think I was bullied by 3 gay bosses at this Starbucks & I got injured and they didn't report my injury." The human resources man named David made a tiny laugh at me on the phone. (June of 2008)

All this happened during ^{the} Obama-Biden
reign with Newsom as the mayor of San
Francisco: great supporters of the gay children.

Trump, however, is a lot more strict but
he has a TRANS ^{celebrity} as a friend.

With all the available candidates, for
president of America, I had to vote for
Trump because I fear the gay children
will be NASTY to ^{me AGAIN} others like they
were to me in 2008. To make things
worse, the heterosexual children who followed
the gays as their leaders jumped in
a gang of 5-7 kids while working as
my co-workers (baristas) to bully the
hell out of me & any new workers they
didn't like. I was just about to turn in

my resignation A ^{WEEK OR TWO AFTER} finishing working that
festival week (AS SOON AS I get to AN ANNUA
doctors appointment, AND ^{ALSO} get a free pair
of prescription glasses); however, HELL IN A
back-STRAINED injury got me first. The
3-5 heterosexual young baristas

to med up with this 1-2 gay-assistant managers
to bully 2 other WORKERS (A SWEET ^{GAY} WHITE
STORE MALE MANAGER & PRETTY JEW GIRL MANAGER
however those 2 managers didn't become
a crippled like me, but I heard the sweet
gay male manager got workers compensation
for mental-illness while the pretty
heterosexual Jewish girl ^{Assistant} store manager quit
and perhaps went to Peet's. Two years later,
I sent 2 copies of my U.S. Supreme Court to
Starbucks headquarter via their lawyers
department, but I heard nothing from Starbucks
19.

C. My Standing Under Product Negligence Claim

As an wanna-be business person working for an ^{INTERNET} search engine company called Infoseek (now in a coma under Disney's purchase), I ALWAYS educated myself ^{WITH} news how corporations always get sued for product negligence by the government and consumers. It baffled me how no business leaders and regular people came out to sue the Respondent (the USA or defendant) under product negligence with ^{the UNPRECEDENTED} vote-by-mail system as only a product of the Respondent being launched so-so fast with cracks & holes (defects) of triple and double mailing ballots being sent to some voters and mailing ballots sent to some dead voters. IF THIS COURT SHUT DOWN MY LAWSUIT, this

Court must answer my product negligence claim and not ignore it like the appeal court & district court. It is your job as a democracy court to answer all claims in lawsuits.

The 5 elements needed to be proven under product negligence tort are duty, breach of duty, cause in fact (causation), proximate cause, and damages - their explanations are listed below:

① Duty - the Respondent (the USA) had a duty to launch a ^{NEW} product (vote-by-mail-system) with no defects that would ^{AGREEMENT} Adhere to the equal voting power among voters given by the "all men are created equal" goal of the Constitution (contract of American democracy). Distributing 2-3 votes to the same voters and votes to dead voters WENT against the equal voting goal of the law of the land ("All men are created equal").

② Breach of duty - The Respondent went ahead and launched & finished with the election of 2020 even though it was well informed by Trump, a few Republican Congressmen & Congresswomen, and many media outlets of the above stated

defects. I suggested a recount-recheck in battle-ground states as a bandage system for the Respondent to fix before announcing Biden was the winner, but no one in district & appeal courts and ^{No} attorneys for the Respondent did anything.

(3) Cause in fact (Causation) - I would NEVER have sued if the Defendant or Respondent was in its clear state of mind during the COVID-19 pandemic to decide not to implement human's ambitious project such as vote-by-mail system as a nation in only less than 3 months in deadly contested election with the country being divided threatening each other with a civil war ^{the GOVERNMENT'S} overforcing the Covid jab & masks onto its people, and jailing its freedom-loving ^{CITIZENS} at home while ^{poor} dead bodies are piling up in poor New York.

(4) Proximate cause - The cost of suing to release my 2020-vote-by-mail-mental-illness made me lose alot of money as a broke, high in credit card debt, ^{AND} jobless semi-homeless human with A FEW credit cards left. Then theres the lost of old brain cells need to write this lawsuit & the lost of hair as an aging female as the result of stress of acting on an impulse to sue to release my pain. My \$1 is worth a lot more than your \$1 for I live a very cheap & frugal life as a semi-homeless: \$200 of filing fee in district court, \$300 filing fee in appeal court, and now nearly \$500 of filing fee in U.S. Supreme Court. Furthermore, ^{we have to factor in} the cost to relinquish my RIGHT & FREEDOM American citizenship. How much do you think your American citizenship is worth?

⑤ Damages - At first I asked for a recount + check in battleground states or \$1 trillion. However, after learning that the Respondent (America) has \$15 trillions in debt via borrowing, I reduced my demand to a simple letter of apology, a letter saying you were wrong, or \$25,000 for the cost of me and those who submit this lawsuit.

D. My Standing Under Federal Tort Claim Act (FTCA)

On my appeal with the 9th Circuit Court of Appeal, I hinted the words "the Constitution," "fair election," "unprecedented," ~~AND~~ "1 vote per voter," but that court didn't understand my memo. Therefore, I will plug in the words "all men are created equal" of the Preamble of the Declaration of Independence as forewords of the Constitution to remind ALL employees of the American government that it was ^{STILL} ~~was~~ ^{THEIR} duty in 2020 to run a ~~president~~ election with a new voting system (vote-by-mail) to reflect the value of the contract of this country via the forewords in the "Preamble." On this appeal, I had to pull out the 12th Amendment of the Constitution to remind you people that ^{THERE IS A} ~~+~~ section called "Election of the President" ~~in~~ the Constitution; therefore, the 2020 election ^{WAS} also an integral item for the Constitution to monitor and protect.

On this claim, I said it was the negligence of all
EMPLOYEES of the American government FOR FAILING TO
PROTECT
the 2020 Presidential Election during the COVID-19
pandemic ^{DRIFTING AWAY FROM} FROM the fair value of democracy ("all
men are created equal") in America when it launched
the voting by-mail system ^{AND FINISHED THE ELECTION} without my suggested bandaid-
solution of implementing a recount-recheck in battle-
ground states ^{BEFORE} announcing the winner of the election.
I pointed out ^{that} the last 2 employees of the Respondent
were Nancy Pelosi & Mitch McConnell ^{THEY} had the power
to stop the work on January 6th, 2021 AND order
a recount-recheck to fulfill their duties to
conduct an "all men are created equal" election
while using the fancy new voting system (vote-by-mail)
with open defects (2-3 mailing ballots sent to same
voter, and mailing ballots sent to dead voters by the
glitches of the computer system).

REASONS FOR GRANTING THE PETITION

- ① Prevent ^{ANOTHER} a civil war in America in 40-50 years with your poor & innocent American children and grandchildren dying because of your egos preventing you from saying sorry and fixing your mistake starting with my lawsuit. Plus preventing destruction of the land and animals in a civil war in such a big country.
- ③ Prove to the founder fathers that their checks-and-balance system still works in America with moi, Trang, as a "nobody" voter rising up to sue to use the last RESORT (the U.S. Supreme Court) to correct the mistake of the Respondent (USA) to prevent the next answer to the problem of ignoring the "all men are created equal" American value of the Constitution VIA 2nd CIVIL WAR.

(Note 1: I would love to have a job at the Social Security office, but I have to work from home. I would love for the Respondent (the USA or defendant) to help me facilitate the process to relinquish my American citizenship to return to Viet Nam. I would love to make America less crazy in gun violence via suing and I love to make America MORE slender again.)
