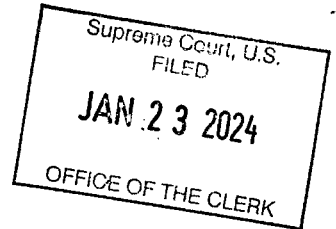

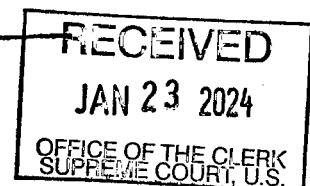

MOTION FOR REHEARING BY THE UNITED STATES SUPREME COURT. CASE # 23-5924 ON FESTUS O. OHAN
v. AMERICAN MEDICAL ASSOCIATION et al.

I AM 100% AVAILABLE FOR TESTINGS THAT INCLUDE GENETIC AND LIE DETECTOR TEST WITH SODIUM
AMYTAL INTERVIEW.

I am A, B, O, Lewis, Duffy, Kell, Rh etc. negative. Thus, not a human as known already. I was injected lots of stuff to be humanized as a child but my genetic remains same. I discovered and reported human creations on different islands along the Mediterranean Sea and was separated from my parents by Judges and my record was sealed. These judges visited me at Woodside Hospital, Woodside, England in February of 1994. Since then, I have discovered and reported most of today's technology. My latest were updating Medicine and Surgery in 2012 and Provisional Patent number TX2666 that includes electric cars. Among other qualifications, I am several times a doctor and became an Institution in 1977. I have never been allowed to enjoy the product of my endeavor but rather, kept at abject poverty level, never been married and have absolutely no children of my own.

Defendants were involved in human creations and did keep all my credentials especially those credentials in health. The National Board of Medical Examiners have over 200 of my credentials and a "Salesforce Account" and so are other defendants. I need all my credentials and direct access to my accounts like the aforementioned "Salesforce account." Unlike humans, my rights are very seriously violated, and I am treated to be less than humans. National Board of Medical Examiners director Frank Corbi confessed on document submitted as a "smoking gun." I am listed in the database of Federation of States Medical Board (FSMB) and National Board of Medical Examiners (NBME) and have never been disciplined nor questioned. Yet, they refused to give me duplicates of my missing by mail credentials. I worked for decades in Health, Education, Welfare, and Institution to make things better as I was made to do yet, not a cent to me even on such one-sided contracts.

This case is not a complicated case to be handled by this court. On the first Saturday of December 1981, defendants promised me that funds would never be a problem. We met in the penthouse of the library building directly opposite Examination Testing Services (ETS), at University of Princeton, Princeton, New Jersey. They told me that I was the only one that can improve world health and contracted me for at least 14 years. In 1981, there were many pathways to becoming a doctor and all had different rigorous tests and I passed all pathways very well. Thus, several times a doctor. I had full and unrestricted licensure to practice medicine and surgery in America. I had passed all written, oral, and practical exams at age 25. Only the Supreme Court can intervene in my case and minimize my decades of suffering.

As always, the Nigerians as Nigerian Mafia were obstructing my mails and negotiating my financial instruments. A case in point was in 1981, when one of them called Chimezie Christopher Duruhesie, phone number 3235351064 and address 1208 E. Denwall Drive, Carson, California obstructed and collected a full unrestricted licensure to practice both medicine and surgery that was issued to me by California Medical Board. After their negotiations, the medical board refused to reissue the license and so were other states, especially New York. They all refused to issue me duplicates. I passed to completion all exams and practicum administered by defendants and at least 3 accredited medical programs that

included AAMC through MSKP and New York regency through Kaplan Medical Education issued me medical degrees that were offset by the said group of mafias.

I am petitioning for rehearing in this case because my case has never been heard and defendants especially the National Board of Medical Examiners and the Federation of States Medical Board have not been told to reissue my credentials and release my funds. I am NBME #353365 with DPO# 1981-0-353-365-001. The Court has not acted but rather dismissed and denied my case all along for no sensible reason. My rights, including civil rights enjoyed by humans, are very seriously violated.

My name Festus John Okwudili Ohan(u) was given to me by natural judges that sealed my file. Biblically, Festus means judge in one of the languages. In both Ibo and Igbo languages, Okwudili means "as said" while Ohan(u) means the globe to hear. In 1981, I made Ohan(u) possible by inventing a thought broadcasting equipment whereby an electrode of say Technetium Potassium Chlorate (half-life is 64 days) is inserted right above the left ear to communicate with the so called "Broca-Winnike-Korsakov area of the brain (aphasive-conductive-receptive). Portable equipment like the ones used for Deaf and Dumb is used to decode and transmit sounds is carried along. A sample was sent to me and offset by Nigerians around me. They inserted it to me while I knapped in an afternoon in Pomona, California in August of 1983 and I have carried it since then. You have a perfect lie detector result when combined with the result of Sodium Amytal interview by an experienced Psychiatrist. They are for court use only. It is just like my group of provisional patents numbered TX2666 by the U.S. Patent office that included advanced electrical cells (and current multiplying system) for automobiles (Elon Musk). Bill Gates, Warren Buffet, and others did me in Loma Linda when Bill was in Loma Linda High School. The Nigerians sold my credit card business like NESPEND to two brothers for 750 dollars and my fax technology to Armenian professor of Computer at Cal Poly and the University of La Verne for 3,000 dollars. Two primary school kids owned Facebook after doing favors to Nigerians. I did a lot in Computer Engineering, and I own BOFI (Business of Ohan Festus Investments/Institutions) Federal Bank and Internet Bank, among others. These were going on while defendants preoccupied me with improving World Health etc. I improved Immunology during Summer of 1985 through Biocel in Carson, California and 1995 to 1999, I developed and tested immune boosters in the Dominican Republic through a European Company called Valtrex. An immune booster called Ad immune was first developed and tested in the Dominican Republic in 1995. As always, I have yet to receive a cent. As always, I was involved in developing most of today's technology and even at age 68, yet to enjoy the product of my endeavor. I am unmarried with absolutely no children of mine. Thanks, and remain blessed.


