

**STATE'S PROPOSED FINDINGS OF FACT,**  
**CONCLUSIONS OF LAW AND ORDER**

This Court has considered the application for writ of habeas corpus, the State's Original Answer, and the official court record in the above-captioned cause, the applicant's previous habeas proceedings, and the original cause. This Court finds that there are no controverted, previously unresolved facts material to the legality of the applicant's confinement that require and evidentiary hearing.

This Court recommends that the instant writ application, cause no. 1104003-D, be **DISMISSED** because the applicant fails to include sufficient specific facts establishing that his current claims were unavailable, or that by a preponderance of the evidence, no rational juror would have found him guilty beyond a reasonable doubt. *See* Tex. Crim. Proc. Code Ann. art. 11.07, § 4(a).

**ORDER**

THE CLERK is **ORDERED** to prepare a transcript of all papers in cause no. 1104003-D, and transmit same to the CCA, as provided by Tex. Crim. Proc. Code Ann. art. 11.07, § 3. The transcript shall include certified copies of the following documents:

1. the application for writ of habeas corpus;
2. the State's Original Answer;
3. the Court's order;
4. the indictment, judgment and sentence, and docket sheets in cause no. 1104003 (unless previously submitted to the CCA);
5. the Court's Findings of Fact and Conclusions of Law; and
6. the State's and the applicant's (if any) Proposed Findings of Fact and Conclusions of Law.
