MOTION FOR LEAVE TO FILE *IN FORMA PAUPERIS*

Petitioner David Allen Sattazahn, through undersigned counsel, moves pursuant to Supreme Court Rule 39.1 for leave to proceed *in forma pauperis* in his concurrently-filed Petition for Writ of Certiorari. Petitioner is indigent; he has sought and been appointed counsel throughout the proceedings below in state and federal court.

In his federal proceedings, Petitioner moved for the appointment of counsel and for leave to proceed *in forma pauperis* in the United States District Court for the Eastern District of Pennsylvania, on July 24, 2017. *See Sattazahn v. Wetzel, et al.*, No. 17-cv-3240 (E.D. Pa. Aug. 16, 2017) (Motion, ECF No. 3). On March 24, 2014, the district court issued an order appointing the Federal Community Defender Office for the Eastern District of Pennsylvania as counsel to Petitioner. *Id.* (Order, ECF No. 5). That order is attached hereto, pursuant to Supreme Court Rule 39.1.

By Order dated July 28, 2021, the United States Court of Appeals for the Third Circuit permitted Mr. Sattazahn to proceed in forma pauperis as well stating that it appeared that Petitioner had satisfied the Court that he was financially unable to obtain representation by counsel. *Sattazahn v. Secretary Pennsylvania Dept., et al.*, No. 21-2372 (July 28, 2021) (ECF No. 3). That Order is also attached hereto.

Undersigned counsel hereby certify that Mr. Sattazahn is incarcerated and remains indigent at present. Mr. Sattazahn respectfully requests that this Court allow him to proceed in forma pauperis.
