
PETITION FOR REHEARING

Of Denial of Petition For Writ Of Certiorari of January 22, 2024 for Review of Nevada State  
Supreme Court Decision of June 8, 2023.

GROUND FOR RE-HEARING

1. PETITIONER has since filed a case of Fraud Against The Court February 24 2024 in Eighth  
District Court of Clark County, Nevada, assignd No A-24-887832 and these accusations are of such  
ease to prove, if only the case were reviewed, this case should be stayed upon remand to County  
Court for a proper will contest which was never done.

2. PETITIONER has filed a complaint with the Department of Justice No. DOJ 515242 HTZ  
alleging officers of the court violated laws, denied me Due Process and Equal Protection and for the  
Court to dismiss the petition has the effect of ratifying unlawful and wholly fraudulent behavior by  
Officers of the Eighth District Court.



3. If the denial was due to procedural error, I offer my apology, and would ask please if The Court could excuse my lack of knowledge. Perhaps it was as simple error such as I never did receive the ' form' needed for proof of service so constructed such similar to others- and opposing counsel never answered , but mentioned knowledge of the filing made in a hearing in Clark County, Nevada Probate court December 15, 2023 Case P-20 103450-E The Estate of Marilyn Sweet ongoing since August 2020. Please know as I am not a resident of Nevada, I have never been able to participate in " Ask the Lawyer" sessions. I cannot afford to hire an attorney.

4.. If the denial was because laws were broken, please could The Court assist in getting proper authorities involved. I could not get any assistance at any time from Clark County police as my mother began the self- harming leading to her 2020 death- while her partner Mr Christopher Hlsgen watched and lied to me to hide her behavior- and indeed the current governor of Nevada Mr. Lombardo, as Clark County Sheriff in 2020- 2021 was one of those people I sent registered letters to but got no reply.

5. If The Court might only see fit, and I have written Justice Kagan who has jurisdiction, asking to remand the Foreign Will Contest case back to the Eighth District Court, Clark County, Nevada. I would consider that significant and grateful for the opportunity to prove my case with Equal Protections and Due Process restored, and would thank The Court with all my heart.
