## QUESTION(S) PRESENTED

1. **Sole Reliance on Statute of Limitations:** Why did the defendants solely rely on the statute of limitations as their claim against me? 4. **Absence of Assistance from City & State:** Why did the City and State fail to provide me, as a taxpayer seeking help, with the necessary support and guidance when I reached out to them after my land was taken from me? I entrusted them to address my concerns and provide assistance in navigating the situation. Their lack of intervention and misleading actions have exacerbated my predicament, and I seek an explanation for their failure to fulfill their responsibilities.
5. **Examination of the Case and Loss of Property:** Can we thoroughly examine the circumstances surrounding the loss of my land and investment? I request a comprehensive evaluation of the case to determine the factors that led to the adverse outcome. Understanding the reasons behind the loss of my property and investment is crucial in seeking justice and appropriate compensation for the damages incurred.
6. **Fairness and Impact on a Taxpaying Citizen:** Is it fair to subject a taxpaying citizen to such treatment, resulting in the loss of property and homelessness? I urge the court to consider the
