

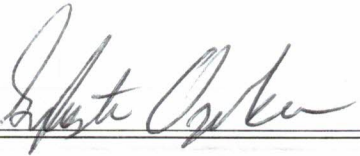

My issues on appeal are:

Is the double jeopardy clause of the United States Constitution violated when the State enters a conviction and sentence for both possession of a controlled substance and unlawful possession of a firearm (for possession of a firearm while in possession of a controlled substance), when the same controlled substance used to satisfy an element in each conviction and sentence.
