My due process in asking for assistance from a higher court was denied.

A lawful and legal petition that sought relevant records was ignored - this information is necessary for state and federal habeas petition.

STATEMENT OF THE CASE

I submitted preprinted court forms requesting records from the Juvenile Court of San Bernardino County.

After following the established protocols I became concerned.

On 9/15/2022 I submitted forms to the involved parties to alert them of my request.

- On 9/28/2022 I submitted copies to the Juvenile Court.

- On 11/8/2022 the Juvenile Court stated it had no records of my request.

- On 11/14/2022 the County Counsel directed to file the forms I was already in the process of filing and had filed.

- On 11/17/2022 I resubmitted the petitions to the Court.

- On 1/24/2023 I resubmitted the petitions again.

- On 3/7/2023 I resubmitted the petitions again.

- On 3/20/2023 the Court responded that they had found no records.

I thereafter also included on 3/20/2023 copies of documents and sent them to the Court of Appeals, 4th Dist, DIV 2 to alert them.

They denied my "writ of mandate" as they labeled it.

I ask the California Supreme Court for a review that was denied.

REASONS FOR GRANTING THE PETITION

This petition should be granted because equity is not being acknowledged. I have as a pro se inmate (indigent at times) followed all the policies, laid out by the the court rules and state law. I followed what the County Counsel directed me to do. and got nowhere.

It has taken a year desperately trying to get records, only to be ignored because I am an inmate. As a free person I would have surely reached a different result.

Where else around our country do Courts simply ignore inmates for simple, straight forward requests. Even when using pre-printed court forms!

The Courts wisdom could do a lot to address this inequality of how petitions are received or ignored.
