**ORDER GRANTING DEFENDANT'S MOTION
TO APPOINT COUNSEL ON APPEAL [87]**

In March 2021, Sanford Schulman took over the representation of Defendant Rajon Jamison. (ECF No. 52.) Schulman represented Jamison through pre-trial proceedings, a change in plea proceeding, and sentencing. Schulman would like to continue to represent Jamison on appeal. But Jamison has provided a sworn financial affidavit indicating that, after several years of being detained, he can no longer afford retained counsel. Thus, Schulman seeks to be appointed as counsel under the

Criminal Justice Act, 18 U.S.C. § 3006A(c). (ECF No. 87.) The government has not expressed any opposition.

Thus, given the benefits of continuity of representation and Rajon Jamison's present inability to afford counsel, the Court will appoint Sanford A. Schulman, pursuant to the Criminal Justice Act, to continue as counsel for Jamison on appeal.

IT IS HEREBY ORDERED that Jamison's motion to appoint counsel on appeal is GRANTED.
