COMES NOW JAMAR GREEN, Petitioner herein, and moves this Honorable Court to permit him an extension of time to file a Petition for Rehearing and as grounds therefore states the following:

1. On June 14, 2024, Petitioner filed his Petition for Rehearing electronically, which was within the twenty-five (25) day timeframe allotted by Supreme Court Rule 44.
2. Petitioner was working with a printer, Lantagne Printing, who filed all the previous briefs in this matter.
3. Lantagne Printing helped Petitioner format and finalize the pleading and planned to file the written brief on June 14, 2024.
4. On August 29, 2024, a Clerk for the Supreme Court contact undersigned counsel and alerted him that no paper copy of the motion was ever filed.
5. The Clerk inquired as to the status of the filing and Counsel herein contacted the Printer who indicated that he had not filed such a Petition before and had called the Supreme Court Clerk's office on June 14, 2024 to seek guidance.
6. The Printer could not recall whether while he was waiting for a reply the matter "slipped through the cracks" or if he instructed his staff to mail a paper copy. He did not have any record of the proceeding.
7. Given that the Petitioner filed a timely electronic copy and that the Printer may have inadvertently failed to mail a paper copy, it is within the interest

of justice to permit Petitioner to file his Petition for Rehearing, which is filed contemporaneously with this Motion.

WHEREFORE, Mr. Green prays that this Honorable Court grant this Motion and permit his Petition for Rehearing to be properly filed.
