## REQUEST FOR RECONSIDERATION

Arnold Anthony Cary, Petitioner, is an inmate within Sterling Correctional Facility (SCF) in Sterling, Colorado. On March 04, 2024 Petitioner submitted per Rule 44 one copy of a Petition For A Writ Of Certiorari to the Supreme Court of the United States, including a Motion For Leave To Proceed In Forma Pauperis. Also, three letters describing US mail fraud at SCF's mail room.

On March 23, 2024 at 9:00 p.m., Petitioner received from the Case Analyst, Sara Simmions, three returned letters for failure to comply with Rule 44. These letters included two exhibits (see enclosed copies) describes SCF's mail room conspiracy to restrain Petitioner's legal mail.

Petitioner inquires, did the Supreme Court receive the mailed Petition For A Writ Of Certiorari? It appears that the Court did not! Enclosed is another copy of the Petition For A Writ Of Certiorari, for the Court's review in order to understand that thousands of inmates within the Colorado Department of Correction (CDOC) are exposed to low-dose radiation year after year, resulting into leukemia and/or some type of cancer.

Petitioner pleads to the Supreme Court to reconsider, and grant the Petition For A Writ Of Certiorari based on Petitioner's living conditions caused by the CDOC's toxic uranium drinking water, resulting in the Petitioner developing cancer and hundreds of cancer related deaths. 
Dear Mr. Harris,

Arnold Anthony Cary (hereinafter "Cary"), Petitioner is an inmate within Sterling Correctional Facility (SCF) in Sterling, Colorado. On October 6, 2023 Cary submitted through a friend in Denver, Colorado, fourth (40) copies of a Petition For Writ Of Certiorari, in a 8½ by 11-inch format. Cary's friend mailed the 40 copies directly to the US Supreme Court, in Washington, D.C.

The reason for submitting through a friend is that SCF's mail room would not allow photocopies of legal documents, required to complete Cary's legal presentation (see exhibit #1).

The 40 copies of the Petitions did not comply with the Court Rules, and they were returned to Cary, by the Court's Case Analyst, Sara Simmons with the docket fees, and ordered Cary to correct the Petition to comply with Court Rules. Upon receipt from SCF mail service these documents were bundled with shipping tape and partially opened.

On December 12, 2023 a notice was given to Cary that this action was placed on the Court's docket No. 23-6229, and notification was given to opposing counsel to file a brief in opposition by Thursday, January 11, 2024, but Cary did not receive a response regarding opposition's brief.



Cary was notified by the US District Court, District of Colorado, that the Petition For Writ Of Certiorari was DENIED, the District Court forwarded a copy of denial from the United States Supreme Court, Washington, D.C.

Cary understands the limited amount of cases heard by this Honorable Court. Cary request reconsideration on the grounds that Cary did not receive due process from the lower courts, and no consideration of facts, or fact-finding were brought into debatable question, to determine the truth.

The fact that Cary's health has failed, and developed into cancer and vision loss, is a direct result of the Colorado Department of Corrections (CDOC), whom will not allow medical treatment that has already been diagnosed by a physician, mandating treatment, without question.

CDOC's Mission Statement, and Clinical Service Mission Statement are not followed as stated in Cary's Statement Of The Case (see ¶'s 15, 16). CDOC will not address physician's diagnostic analyzation of Cary's illnesses as outlined in Introduction Of Petition (see ¶'s 1-12). Cary is also aware of numerous inmates inflicted with different types of cancer; these are life threatening and compelling reason to reconsider Cary's medical situation as a matter of life or death!

To intensify and make matters worse, Cary's telephone service has been completely shut-off for months, since bringing forth this action. Cary's legal mail has been fraudulently withheld. Enclosed is a letter to the United States Postal Service, showing

mail fraud inflicted upon Cary. Every time Cary's legal actions moves forward, CDOC delays or tries stopping Cary's legal actions (see exhibit #2).

Cary pleads to this Court to reconsider granting his Petition For Writ Of Certiorari, in order to save his life, and numerous inmates inflicted with various types of cancer, and heart disease caused by toxic uranium drinking water within CDOC facilities!
