STATEMENT

1. This is civil action filed to repair the civil standing of a case entitled *Velasquez v. Utah et al.* wherein judiciary forcefully impaired the United States District Court, District of Utah Jurisdiction by disparagement of the legal pleadings filed with the court, defined to be part of the court's record, impaired the Appellant as plaintiff's access to the record.
2. The Judiciary were originally served by *mail* in the District Court, *Summons* and *Complaint* with *Appendices*, however theirs never returned *service* and so have provided no other points of contact than the Orrin Hatch Courthouse in Salt Lake City, UT, and the Byron S. 

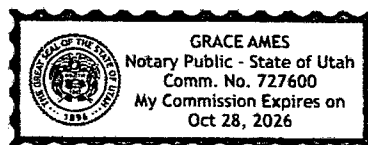


