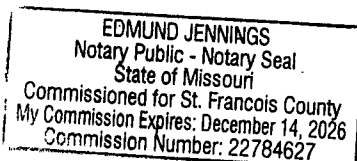

On 8-30-23 I turned in my petition for Writ of Certiorari to the United States Supreme Court, after being instructed to correct the petition, and I turned in a copy to Michael Joseph Spillane, Missouri Attorney General's office at 207 W. High St. P.O. Box 899 Jefferson City, MO 65102 on the same date (USPS tracking # 9114, 9014, 9645, 1174, 0972, 86) in compliance with Supreme Court Rule 29. The petition was returned September 7th 2023, instructing me: The lower Courts opinion(s) must be appended, and a copy of the corrected petition must be served on opposing counsel, within 60 days from the date of the letter, rule 14.5.

I am including all movements by all state and federal courts with the exception to these 17CV-CV04525 Shallen Hawkins V. State of Missouri: 6-11-19 order for hearing/trial cancelled, 7-2-19 writ dissolved, and these Hawkins V. Vandergriff 4:22-CV-00167-GAF (DOC# 7) Case transferred in from District of Missouri Eastern, case # 4:22-CV-00219 and (DOC# 29) Transmission of notice of appeal Supplement to U.S. Court of Appeals 8th Circuit via electric Mail, due to these being entries to the docket sheets. As stated the petition was served to opposing party on 8-30-23. The petition is the same with the exception to the Index to Appendices, table of Authorities cited, and additional appendices. I have also corrected the proof of service, financial affidavit, motion for order to subpoena evidence and motion for order for Department of Corrections to provide television with applicable electronic devices with working connections to review the video evidence.
