**REHEARING REQUESTED AS PER
NEWLY DISCOVERED INTERVENING
CIRCUMSTANCES.**

This Petition of Rehearing is strictly limited to substantial grounds not previously presented and to the newly discovered intervening circumstances.

The Honorable Court is currently reviewing Federal Arbitration Act and how it applies to employees and class of workers in interstate transportation in the case of, *Neal Bissonnette, et al., v.
