REASONS FOR RULING AND ORDER

This cause was before the Court for filings by defendant Roy Jackson dated September 21, 2022 and filed September 26, 2022 again attempting to proceed with a Uniform Application for Post-Conviction Relief.

Jackson entered a plea of guilty pursuant to a plea agreement on November 14, 2011. Since that time, Jackson has filed multiple Applications for Post-Conviction Relief and/or other Post-Conviction Motions and/or filings. All were DENIED by this Court and/or by the Court of Appeal, Third Circuit and/or the Louisiana Supreme Court.

Further, on August 12, 2019, the Louisiana Supreme Court issued a ruling that provides as follows:

"Writ Application denied. Applicant has previously exhausted his right to state collateral review and fails to show that any exception permits his successive filing. See State ex rel. Jackson v. State, 15-1731 (La. 10/10/16), 201 So. 3d 879."

In the current filing Jackson again fails to show any exception that would allow this additional Uniform Application Post-Conviction Relief to proceed. Code of Criminal Procedure Article 930.4 addresses the filing of repetitive applications and none of the provisions of Article 930.4 provide relief for Jackson to file this repetitive application. Further, this application is clearly untimely.

IT IS ORDERED that the filings by Roy Jackson on September 26, 2022 are hereby DENIED and/or DISMISSED.

WRIT DENIED: Relator filed a writ application with this court seeking supervisory review of the trial court's September 30, 2022, ruling denying Relator's application for post-conviction relief. Relator's judgment of conviction and sentence became final in January 2012 when Relator failed to file a motion for appeal within thirty days of the denial of his motion to reconsider sentence. La.Code Crim.P. arts. 914, 922. Relator then had two years from the date his conviction and sentence became final, until January 2014, to seek post-conviction relief. La.Code Crim.P. art. 930.8. Relator filed his current application and supplemental application with the trial court on September 26, 2022, which was beyond Relator's time for seeking post-conviction relief. Therefore, Relator's pleadings were not timely filed with the trial court. *See State v. Jackson, 18-1712 (La. 8/12/19), 279 So.3d 930; see also, State ex rel. Jackson v. State, 15-235 (La. 1/13/17), 206 So.3d 873; and see, State ex rel. Jackson v. State, 15-1731 (La. 10/10/16), 201 So.3d 879.* Moreover, Relator fails to either allege or prove a valid exception to the time limitation. Accordingly, Relator's writ application is denied.
