Defendant/Movant Richard Duerson has filed a motion for leave to proceed *in forma pauperis* on appeal following the denial of his motion under 28 U.S.C. § 2255. Rule 24 of the Federal Rules of Appellate Procedure govern proceedings on appeal *in forma pauperis* with respect to § 2255 motions. *Kincade v. Sparkman*, 117 F.3d 949, 951-52 (6th Cir. 1997). The rule generally provides that a party who was permitted to proceed *in forma pauperis* in the district court action may appeal *in forma pauperis* without further authorization. Fed. R. App. P. 26(a)(3).

Although Duerson subsequently retained counsel, he was deemed indigent and was appointed counsel for the first eight months of the district court action. More recently, he was granted pauper status in December 2022 for purposes of appealing the Court's denial of his motions for a new trial and reconsideration. Accordingly, it is hereby

**ORDERED** that Defendant/Movant Duerson's motion for leave to proceed on appeal *in forma pauperis* [Record No. 224] is **GRANTED**.
