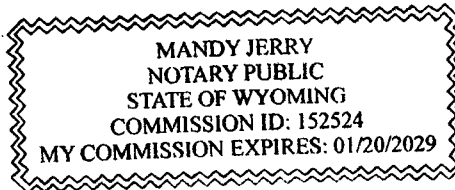

These updates/corrections were completed on 12/18/23 but they did not let me print it until 12/18/23 and notarize it on 12/28/23. I could not mail the copies until 1/12/24 because they would not let me receive my friend's check until 1/3/24 and did not apply it to my account until 1/10/24. The copies were made on 1/12/24 and I am mailing it on the above date. I swear this info is true & correct under the penalty of perjury to the best of my recollection. I tried to mail it on 1/12/24 but was told it would not be accepted until 1/16/24 for mailing. I tried to expedite it but the WDOC delayed it every step of the way. 1/16/24 Mrs. Shan said she was working Delta down and would not accept it until 1/17/24. On 1/17/24 at Breakfast Mrs. Shan said to wait until 10:00 and bring the filing

OVER

to her office for mailing. At 09:55, when I was waiting for Mrs. Shaw to arrive, the officer doing his rounds informed me Mrs. Shaw could not be back for quite some time because she was doing something else. At 12:06 on 1/17/23, Mrs. Shaw told me that I have spoken to her too many times regarding getting this legal filing mailed and she will call me to her office when she is ready for me to bring the filing to her for mailing.
