Abraham Hutt has filed a motion to withdraw from further representation of Appellant Charles Ramon, III in this appeal. The motion to withdraw is GRANTED.

The district court has made the requisite finding of eligibility for appointment of counsel pursuant to 18 U.S.C. § 3006A, and Kari S. Schmidt<sup>1</sup> is appointed as counsel for Appellant Ramon. Pursuant to § 3006A, Mr. Hutt is appointed *nunc pro tunc* to the date the notice of appeal was filed in this matter, and that appointment ends with the entry of this order appointing new counsel.

Within ten days from the date of this order, Mr. Hutt shall transmit to Ms. Schmidt copies of all documents in his possession that are pertinent to this appeal and not otherwise available via PACER and/or CM/ECF.

Within ten days, Ms. Schmidt shall file an entry of appearance in this appeal. Mr. Hutt has filed a designation of record and a transcript order form for this appeal. Within 20 days from the date of this order, Ms. Schmidt shall file any supplemental designation of record and any supplemental transcript order form. If any additional transcript is ordered by Ms. Schmidt, she must file a CJA 24 form in the U.S. District Court for the District of Colorado.

Appellant's opening brief shall be due 40 days from the date the record on appeal is filed in this court. *See* Fed. R. App. P. 31(a)(1); 10th Cir. R. 11.2(A). The Clerk of the U.S. District Court for the District of Colorado shall wait at least 20 days before transmitting the record on appeal to this court.

The Clerk's Office shall transmit a copy of this order to the district court clerk. Mr. Hutt shall transmit a copy of this order to Appellant Ramon forthwith.
