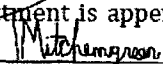

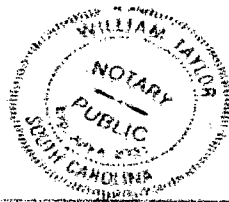

**PETITION FOR REHEARING: EMERGENCY SUPPLEMENTAL BRIEF FOR THE PETITIONER

Pursuant to Rule 15.8, petitioner submits this supplemental brief to address new developments regarding all three Questions, which are as follows:

1. *Was the US Court of Appeals for the Fourth Circuit in error dismissing the appeal for a "lack of jurisdiction," after having held on to the case for over six (6) months, far exceeding the Informal Brief Order timeline?*
2. *Was the US District Court of South Carolina in error:*
 - a. *In remanding case back to Lexington County Courthouse, despite being presented evidence of partial treatment received with egregious civil rights and legal right violations?*
 - b. *In requiring release of requested sealed documents to Lexington County Courthouse, despite being notified of targeting occurrences and Defendants request for Witness Protection, Federal notification and investigation?*
3. *Was U.S. Bank National Association in error:*
 - a. *By failing to use ordinary care [i.e. follow guidelines and comply with applicable law(s)] in processing the Mortgage Assistance Program Application?*
 - b. *By intentionally and deliberately failing to appropriately process the Mortgage Assistance Program application?*

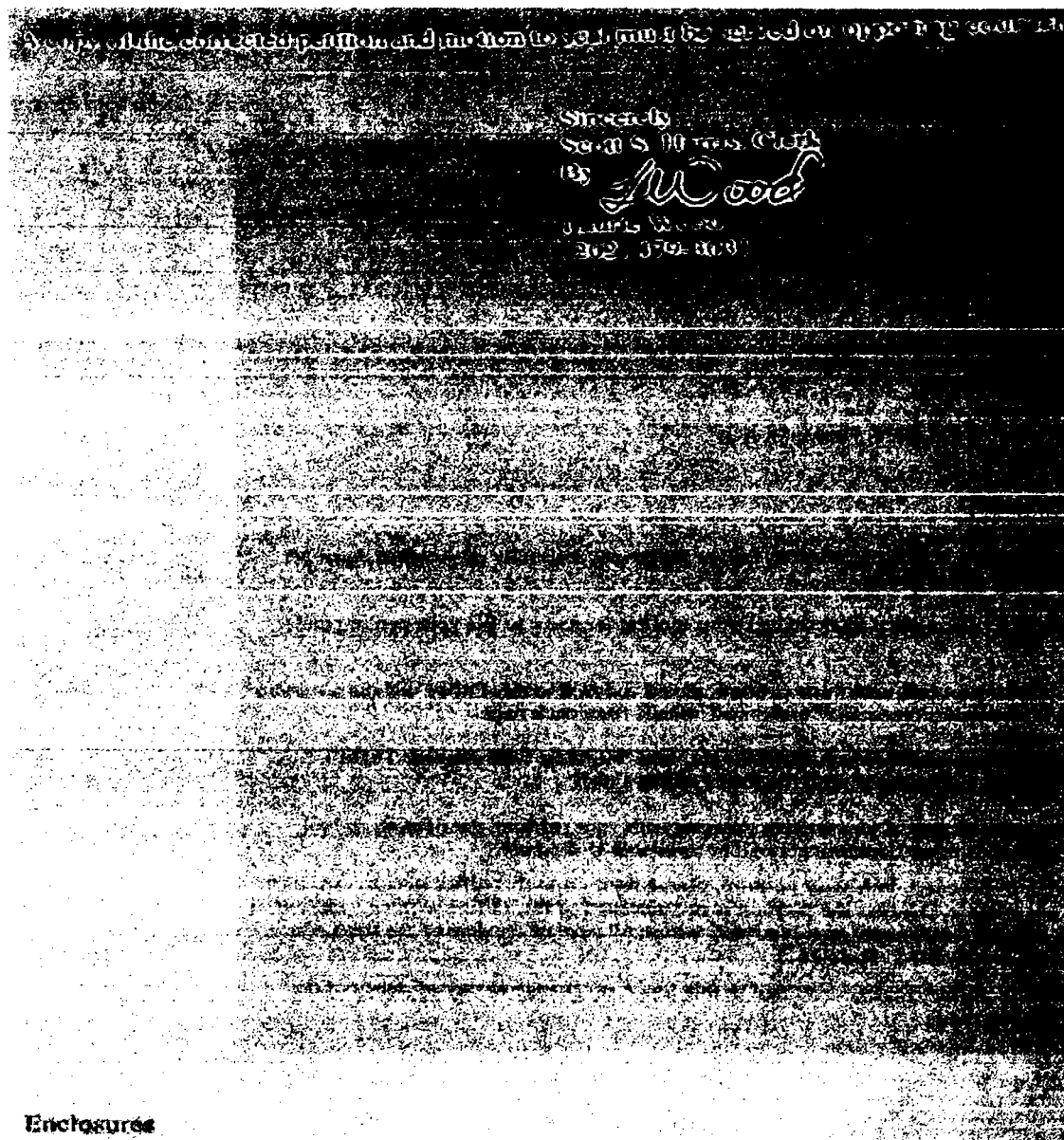

I received your letters, both dated October 2, 2023. Below is my response;

1. Attached is my UNsealed, UNcorrected petition for a Writ of Certiorari, which invokes Rule 11. [NOTE: I only received 10 copies back; 11 copies are included with this letter.]
2. There is confusion regarding the motion to seal. Lines 5-6 of your letter, Your Honor Wood, reads 'If you wish to proceed with your petition, please return it to this Office without a motion to seal. You must remove the "under seal" label from each page.; and lines 11-16 reads "If you wish to proceed with your petition, please return it to this office in corrected form as soon as possible. Unless the petition is re-submitted to this Office without a motion to seal and without "under seal designations" within 60 days of the date of the letter, the petition will not be filed. Rule 14.5. When making the corrections outlined in this letter, no change to the substance of the petition may be made." However, Your Honor Wood, on the second page, the single sentence reads "A copy of the corrected petition and motion to seal must be served on opposing counsel." Thus, I performed the following tasks:
 - a. I removed the "under seal" label from each page.
 - b. I included a three-paged MOTION TO UNSEAL DOCUMENTS. NOTE: Prior to completing this, I called your office multiple times on November 6, 2023 but only left two voice messages. In addition, I sent an electronic notice to the Public Information Officer on November 7, 2023, received confirmation the notice was received, but still did not receive a response to either communications. NOTE: In the messages, I was inquiring about whether the following mailings were received by your office: the Writ of Certiorari for US Court of Appeals for the Fourth Circuit; and the letter notifying you of a letter returned to the Fourth Circuit [9505 5124 5336 3305 6105 96] due to suspected mail tampering [USPS 9505 5124 5336 3305 6106 19]. Since I was unable to speak with someone from your office, I attempted compliance to your written request the best I knew how; please correct me if I am wrong. My understanding of public availability of documents is addressed in the Motion to Unseal Documents. [Below are verifications of communications referenced.]
3. I refrained from including the "criminal derailment" and "targeting" documents since these submissions do not comply with the Rules of the Court. Again, I am humbly requesting expedited processing of this petition and witness protection initiated, please.

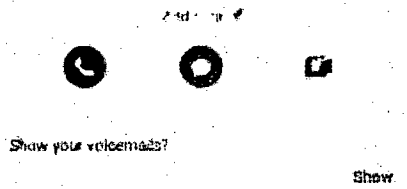

Dear Westgate Owner,

I have been trying to help you choose an option to help you avoid the foreclosure process from happening with no success.

We have options for you. (Even if your account already foreclosed).

Please call me at 407-355-2002 ext. 8316 so I can help you before it is too late....

In addition, I received the 5/30/23 858pm email from a new email address, owner_mediation@wgresorts.com, indicating a tax lien has been placed on the previously surrendered timeshare (voluntarily surrendered August 18, 2021). Here is a copy of my statement emailed to three Westgate Resorts recipients on May 29, 2023:00am:

On 5/27/23, I received a 5-page certified letter--addressed to 123 Cardinal Pines Dr, Lexington SC 29073--from Westgate Resorts, dated 4/20/23, giving me thirty-five (35) days from the date of receipt to pay \$3964.17, relinquish ownership by executing the Warranty Deed In Lieu of Foreclosure, or face foreclosure. Here are my questions/comments:

1. Despite being notified on 4/16/23 of the correct mailing address, the certified letter was mailed incorrectly. Again, please send all mail to PO Box 521, Yonkers NY 10710.

2. Why am I now being permitted the opportunity to relinquish ownership of the Nineteen thousand dollar (\$19,000) Timeshare (with a contract date of March 15, 2017)--of which I thought was already completed in year 2021 without any monetary exchange--for a ten dollar (\$10) payment from Westgate Resorts when ownership relinquishment was initiated by me in year 2021? The amount of Maintenance and Tax due is now higher than it was in the year 2021, which is not my fault. Also in year 2021, instead of being given the same opportunity to relinquish the timeshare I am now being afforded--again of which I thought was already completed without any payment from Westgate Resorts to me or vice versa --I was told in order to qualify for financial assistance to relinquish the timeshare to Westgate Resorts, I would have to pay one thousand (\$1000) dollars to do so. Why was I not offered the chance to relinquish my timeshare during negative talks earlier this month, instead being offered to pay for an entirely different timeshare? Why the discrepancy and inconsistency in procedure?

3. Why was the threat of foreclosure letter, dated April 20, 2023 (4/20/23), sent out before the completion of our talks of negotiation, which ended May 12, 2023 (5/12/23)?...NOTE: The date I personally received the certified letter above was May 27, 2023; thus the 35-day time limit has begun. Please advise. Something is not right with this situation; be advised, undue hardship and harm has occurred because of this...

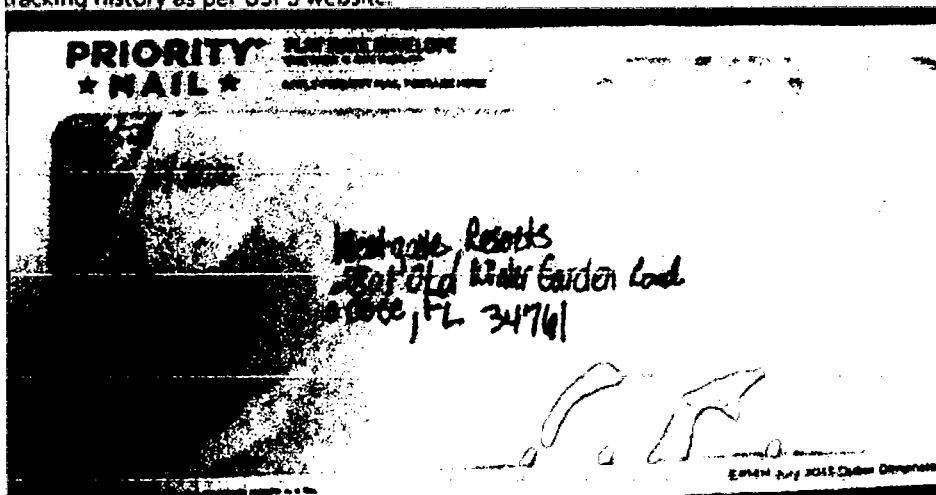

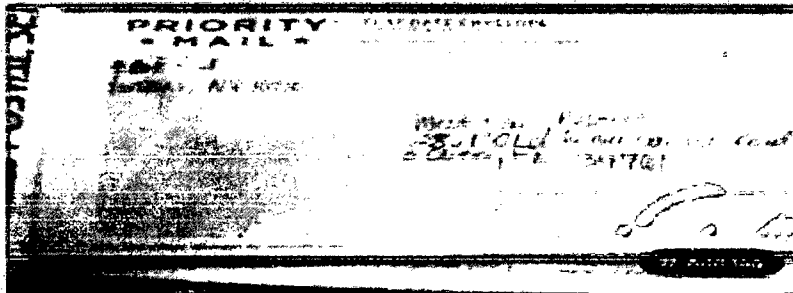

Medicaid Insurance was denied due to reported missing paperwork. The office has been contacted with the confusion cleared up. I am awaiting a response.

Supreme Court of the United States Online Court-Appointed Attorneys, Goldberg, Stinnett, and MacDonald:

A Reported Glitch

On April 23, 2024, I wrote the following to the Supreme Court Privacy officer:

Thank you for the 4.19.24 1005am email giving instructions how to contact the Clerks office; Angela called. Here is what I was told:

- 1. Nothing to do about the Conference; it is private.*
- 2. Only item pending is rehearing for informa pauperis. I can file for further extension after the hearing.*
- 3. No attorney on file; I am still ProSe. Attorneys Goldberg, Stinnett, and MacDonald listed online is a glitch.*
- 4. All documents received 4.15.24 were reviewed by D.Clerk Jeff Atkins, deemed inappropriate and place in my file, including the two emergency motions 1) requesting Stay return to SC with the newly added Appendix (as instructed); and 2) removal of attorneys from my record with requested response date 4.19.24. I am awaiting a callback from Angela regarding further questions on these emergency motions as the Appendix added as per Clerk Harris instructions; and if the listed attorneys were a glitch then why are the attorneys still listed online. I also have a question about the status of the writ of certiorari. "I HUMBLY REQUEST ANGELAS RETURN CALL TODAY, PLEASE. Angela was very pleasant, polite and informative. Thank you.*

As discussed in the submitted but not docketed Supplemental Brief with Appendix (dated

February 22, 2024) to the Writ of Certiorari to US Court of Appeals for the Fourth Circuit

(dated December 20, 2023); and the Writ of Certiorari to US District Court of South Carolina

(dated July 11, 2023);

The experiences of Officer Pisciotta after reporting the truth of what he saw in "Whistleblower prison guard paid the price for reporting abuse", still hold true to my families experience since I lawfully reported what I saw occurring. In addition, Prison Legal News article, "Florida's Department of Corrections: A Culture of Corruption, Abuse, and Deaths" still appears to capture what I have seen and experienced. Again, Department of Justice notification is warranted and requested; if the Supreme Court does not intervene quickly, it is probable more innocent lives will be damaged and lost. The time to act is now, please.

This foreclosure case is connected to Federal Case No 3:20-cv-00054-BJD-PDB, U.S. District Court Middle District of Florida and Federal Appeal Case No 21-11611, with US Court of Appeals for the Eleventh Circuit. As detailed in the two notarized Affidavits already docketed with the Court, these two cases, which were suspected to be criminally derailed, were a mouthpiece for thousands of American

citizens who are limited or unable to speak for themselves, as to what they have suffered; and what this Petitioner witnessed. Again, this current foreclosure case solely developed because of the above listed cases; thus giving credence to its true nature-- frivolous, unlawful, and based in retaliation. As per the Supreme Court of the United States mandate, Case 23M16, Green v US Bank National is no longer Under Seal and appended. Sanctions are warranted and monetary awards are in order against the mirage of perpetrators, both individuals and businesses alike, who have participated in the retaliatory efforts. In addition, the suspected murderous attempt on my life [and my child if he would have been present at the time of the "accident"] and the suspicious "accidental" death of the son of another suspected target, Donna Washington Farmer, gives rise for federal investigation into home-grown terrorism. I expect such "accidents" to continue; thus I am humbly requesting expedited processing and witness protection initiated, please.

A plethora of attempts to obscure truth and subvert justice have occurred and continues to occur; thus the filing of this Supplemental Brief. This case is of national importance as it encompasses the following:

1. Judicial employees brazenly operating in contradiction to the very oath the public expects them to adhere to: "...do solemnly swear (or affirm) that I will administer justice without respect to persons, and do equal right to the poor and to the rich, and that I will faithfully and impartially discharge and perform all the duties incumbent upon me...under the Constitution and the laws of the United States. So help me God."
2. The calculated manner a supposed pillars of society, U.S.Bank National et al, uses to subvert the laws of the United States of America, including the Constitution of the United States and the Civil Rights Act of 1964. To not hold U.S.Bank National and all associates accountable for this frivolous lawsuit would be a silent vote for lawlessness to continue, thus destroying our society and the very fabric of our constitutional federal republic from the inside out. Printed on the back of the American dollar bill are the words "IN GOD WE TRUST". It is written in Ecclesiastes 8:11, Because sentence against an evil work is not executed speedily, therefore the heart of the sons of men is fully set in them to do evil. Thus, this case presents issues of importance beyond the particular facts and parties involved....

A lot more is occurring here than meets the eye; thus the request for sanctions and appropriate federal agency notification with request for investigation into all occurrences.

This case is of national importance as it encompasses the following:

1. Judicial employees operating in contradiction to the very oath the public expects them to adhere to: "...do solemnly swear (or affirm) that I will administer justice without respect to persons, and do equal right to the poor and to the rich, and that I will faithfully and
2. Impartially discharge and perform all the duties incumbent upon me...under the Constitution and the laws of the United States. So help me God."
3. The harm of American citizens attempting to be concealed in a discrete,

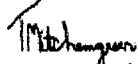
- coordinated effort by several persons and/or entities.
4. The undermining of due process, ultimately negatively affecting every American citizen.
 5. Details the calculated manner the Nazi-type Network has infiltrated American society and destroying the very fabric of our constitutional federal republic.

The stalling of this case in the Court of Appeals for the Fourth Circuit; the inconsistency of whether US Bank National timely filed an Informal Brief Response in the same Court; the decision of US District Court of South Carolina to remand the case back to Lexington County Courthouse and order a release of all documents (i.e. sealed documents) was alarming. Furthermore, all said Courts have yet to respond to reported egregious, unlawful experiences [see detailed information under Issue 3 of the attached Informal Brief]. Moreover, the death of her son earlier this year is quite suspicious. Witness Protection is warranted and requested as well as notifying the Department of Justice, the Internal Revenue Service, and other appropriate federal agencies. Again, this Defendant moves for sanctions and a monetary award for damages against Plaintiff US Bank National and its five Attorneys under Rule 11 of the Federal Rules of Civil Procedure for the filing of this lawsuit as well as sanctions of persons and/or entities recorded under the List of Parties section as deemed appropriate by the Court.

CONCLUSION

For the foregoing reasons, the judgement revoking informa pauperis status should be reversed.
