

Harry William Lott filed a notice of appeal in the Fourth District Court of Appeals from the trial court's August 16, 2023 judgment entry which dismissed his legal proceeding because he did not first obtain leave of court pursuant to R.C. 2323.52. Mr. Lott was declared a vexatious litigator on August 18, 2014 by the Washington County Common Pleas Court (Case No. 13OT361). Pursuant to R.C. 2323.52(D)(3),

A person who is subject to an order entered pursuant to division (D)(1) of this section may not institute legal proceedings in a court of appeals * * * or make any application, other than the application for leave to proceed allowed by division (F)(2) of this section, in any legal proceedings instituted by the vexatious litigator or another person in a court of appeals without first obtaining leave of the court of appeals to proceed pursuant to division (F)(2) of this section.

Because Mr. Lott did not seek leave to proceed before attempting to institute legal proceedings in this Court, his case is **DISMISSED**. Costs to appellant.

The clerk is **ORDERED** to serve by ordinary mail a copy of this order to all counsel of record and to all unrepresented parties at their last known addresses. **IT IS SO ORDERED.**
