Dear Mr. Harris:

On behalf of the Respondent in this matter, and pursuant to Rule 30.4, I respectfully request a 22-day extension to file the Brief in Opposition, extending the May 1, 2024, deadline to May 22, 2024. The extension is necessary because the Office of the Solicitor General has a number of pressing deadlines in various other matters with limited staff assistance. Along with its obligations in other state and federal courts, the Office is currently responding to numerous other petitions raising the same issue Petitioner raises here: the constitutionality of Florida's use of six-person juries. Because Florida tries all noncapital crimes before six-person juries, new petitions raising this issue are filed constantly.<sup>1</sup> The Court began calling for responses to such petitions in August of 2023, and
