

**WRIT DENIED:** Relator filed a writ application with this court seeking supervisory review of the trial court's June 13, 2022, dismissal of his application for post-conviction relief filed in April 2022. Relator's April 2022 application for post-conviction relief was untimely filed. Applications for post-conviction relief are bound by the prescriptive period set forth in La.Code Crim.P. art. 930.8. Relator's judgment of conviction and sentence became final in 1987. La.Code Crim.P. arts. 814, 922; *State v. Poydras*, 514 So.2d 516 (La.App. 3 Cir. 1987). The post-conviction relief articles were enacted by 1990 La.Acts No. 1023, §1 and became effective October 1, 1990. Thereafter, Relator had until October 1, 1991, to seek post-conviction relief. Relator filed his petition with the trial court in April 2022, which was beyond Relator's time for seeking post-conviction relief. Therefore, Relator's April 2022 application for post-conviction relief was not timely filed with the trial court. Moreover, Relator failed to establish an applicable exception to the time limitation. See La.Code Crim.P. arts. 926.2, 926.3, 930.8, 930.10. Accordingly, Relator's writ application is denied.
