ORDER DISMISSING APPEAL

The court has reviewed the record pursuant to its duty to determine whether it has jurisdiction over this appeal. See *Sorensen v. Farmers Ins. Co.*, 191 Ariz. 464, 465 (App. 1997).

In an unsigned minute entry filed April 4, 2023, the superior court granted appellees' motion to dismiss. Appellees subsequently filed a motion for attorney fees and costs. Appellant filed a notice of appeal on July 4, 2023, while the motion for attorney fees and costs was pending. The superior court entered a final judgment on July 11, 2023 that resolves the attorney fees and costs issues.

The notice of appeal is premature and a nullity because it was filed while the attorney fees and costs issues were pending and before a final judgment was entered. *Camasura v. Camasura*, 238 Ariz. 179, 182-83, ¶¶ 9-16 (App. 2015); *Fields v. Oates*, 230 Ariz. 411, 414-15, ¶¶ 10-14 (App. 2012). Therefore,

IT IS ORDERED dismissing this appeal. Nothing precludes appellant from filing a timely notice of appeal from the July 11, 2023 judgment.
