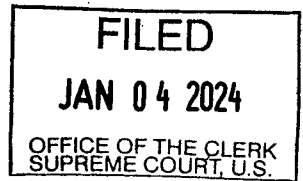

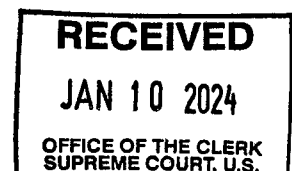

## QUESTIONS PRESENTED

1. The Lufthansa Airlines has been ignoring my letters my phone calls and my emails for the last two years. 
