

- i) Did the district courts utilization of Rule 4 of §2254 to dismiss with prejudice the Petitioner's §2241 petition, without opportunity to amend, violate clear meaning and scope of the rule?
- ii) Did the court below err as a matter of law by ignoring its own precedence regarding the standard of review in cases of summary dismissal by a district court?
