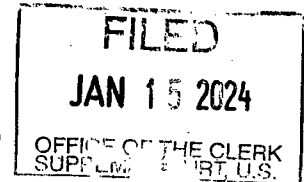

Declaration In Support Of Motion For Leave To Proceed In Forma Pauperis question 12  
Frank Bernard Johnson

In the above section I put forth my best effort to accurately quantify my monthly income and expenditures. Recalling my annual expenses allowed me to reflect on the past year as well as years prior. Taking measure of my expenses in this way is an act that as of recently has become quite foreign to me. Fearfulness of not being able to manage my funds or ultimately defaulting on my debts and obligations is a haunting notion; which often compels me in many financial instances to abstain from noting or itemizing purchases in deliberate detail; I instead often maintain a willful ignorance regarding my adequacy of funds. While I regard this self-admitted practice as both shameful and detestable; I am grateful to both God and natural circumstances for providing me the means to keep the reality of abject poverty at bay or at least deferring its approach for the time being. My current financial circumstance is such that the majority of my expenditures are paid on credit and my wages most months are applied directly to that debt's reduction. Over the last year circumstances, many of them unforeseen have revealed the fragility in my methodology as it pertains to my management of funds. I currently have a missing daughter and an ill relative and between the unexpected expenditure of funds that come with trying to locate my daughter and providing increased assistance to my ill relative, time has also become a scarcity which has impeded my ability to financially accommodate these changes in schedule and fluctuations in finance. I would be remiss if I didn't regard my parental pursuits as a contributing factor, albeit a modest contribution monetarily. At the end each month after paying my credit card bill I typically have between \$5.00 and \$ 25.00 remaining in my checking account. As I stated previously I'm grateful to both God and the Universe for providing me the appropriate means thus far, and the realization of the frailty of my financial condition becomes

more apparent with each day that doesn't lead to finding my daughter and with each hospital visit with my ill relative. As it relates to this particular matter in which I am attempting to bring before the court, I've had the experience of both promptly paying a filing fee when requested by a lower court as well as filing as indigent at another lower court at time in which the remainder of the funds in my checking account had already been allocated toward placing an order of publication in The Washington Times, in the hopes of finding my daughter the following day. Ultimately that filing was dismissed and deemed untimely due to the fee not being satisfied as well as proof of indigency not adequately satisfied. This being the highest court as well as potentially the first and last opportunity to have my appeal heard, I humbly request the court's consideration of my request to proceed In Forma Pauperis.
