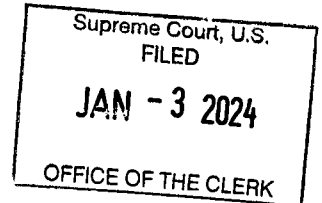

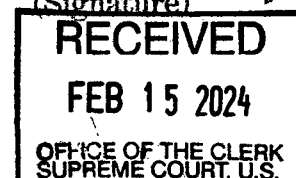

ORDER OF COURT¹

Before the Court is Petitioner Robert Paul Brozenick's motion for leave to appeal *in forma pauperis* (ECF No. 25). For the reasons that follow, the Court will grant Petitioner's motion.

On November 9, 2022, Petitioner filed with this Court a Petition for Writ of Habeas Corpus pursuant to 28 U.S.C. § 2254 in connection with his 2018 convictions in the Court of Common Pleas of Allegheny County, at Case No. CP-02-0002351-2017, of four misdemeanor counts of Terroristic Threats and four misdemeanor counts of Simple Assault. Contemporaneously with the filing of the Petition, Petitioner paid in full the \$5.00 filing fee. (ECF No. 1, receipt number 200001176). On December 2, 2022, Petitioner filed an Amended Petition. (ECF No. 6).

By Memorandum Opinion and Order filed May 15, 2023, the Court dismissed the

APPENDIX B Pg. 1-3 FORMA PAUPERIS GRANTED ORDER OF COURT
WESTERN DISTRICT PENNSYLVANIA FEDERAL COURT

Petition for lack of subject matter jurisdiction finding that Petitioner was not "in custody" at the time the federal habeas petition was filed. (ECF Nos. 21 and 22). On June 5, 2023,, Petitioner filed a Notice of Appeal (ECF No. 23) and on June 28, 2023, filed the instant Motion for Leave to Appeal *in forma pauperis* (ECF No. 25).

The Federal Rules of Appellate Procedure set forth the manner in which a litigant is permitted to seek leave to appeal *in forma pauperis*. Specifically, Rule 24(a)(1) of the Federal Rules of Appellate Procedure provides, in relevant part:

[A] party to a district-court action who desires to appeal in forma pauperis must file a motion in the district court. The party must attach an affidavit that:

(A) shows in the detail prescribed by Form 4 of the Appendix of Forms the party's inability to pay or to give security for fees and costs;

(B) claims an entitlement to redress; and

(C) states the issues that the party intends to present on appeal.

Fed. R.App. P. 24(a)(1).

In his motion to appeal *in forma pauperis*, Petitioner lists his income source as a monthly disability payment of \$1605.00. He lists no other income or assets. His monthly expenses total \$1570.00, which includes \$1000.00 for rent or home-mortgage payments, \$70.00 for utilities, and \$500.00 for food. (ECF No. 25). The Court thus finds that Petitioner adequately sets forth his inability to pay fees and costs associated with this appeal.

The Court observes, however, that Petitioner does not include with his motion an entitlement to redress, nor does he state the issues he intends to present on appeal. However, the Court is cognizant that it must liberally construe a *pro se* litigant's pleadings, and the Court believes Petitioner does clearly set forth in his Notice of Appeal the issues that he intends to pursue in appealing the Court's Memorandum Opinion and Order. (See ECF No. 23.)

Accordingly, because Petitioner has made an adequate showing of financial need, the Court will grant Petitioner's motion for leave to appeal *in forma pauperis*. See *Mauro v. New Jersey Supreme Court*, Case No. 56,900, 238 F. App'x 791, 793 (3d Cir. 2007) ("The decision whether to grant on appeal in forma pauperis depends solely on whether the applicant is economically eligible; we do not consider whether the action or appeal is frivolous.")

An appropriate Order follows.

ORDER

AND NOW, this 28th day of June, 2023, **IT IS HEREBY ORDERED** that Petitioner's motion for leave to appeal in forma pauperis is **GRANTED**.
