



Motion for Reconsideration to Proceed *in forma pauperis* (without payment)

On April 24, 2024, I was electronically notified by the US District Court Eleven of Atlanta, GA that the US Supreme Court Denied my request to proceed *in forma pauperis* (without payment) and have given me until May 13, 2024 to pay \$300.00.

I request for this Motion for Reconsideration to proceed without payment because, in accordance to the US Supreme Court's Rule and form (**MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***) for me to proceed *in forma pauperis* (without payment), **(1)** I have provided/submitted the US Supreme Court proof from the lower court showing this motion was granted for me to proceed without payment in their court, as the US Supreme Court required/requested of me to provide which, was submitted to the US Supreme Court and signed by me on January 5, 2024; **(2)** Further, I am also still a current Recipient of a Federal Social Services Benefit Program; **(3)** In addition, I do not have any income to pay \$300.00 to proceed and unfortunately, I cannot financially afford to pay such a fee which, is another major reason why I am in desperate need for my disability benefits to be retroactively awarded and released to me so that, I may be able to financially care for myself and take care of any responsibilities or current/future unexpected financial burdens needed for me to live and do so in my daily life. **(4)** I have also provided/submitted the financial statement portion of the *in forma pauperis* which, was also submitted to the US Supreme as requested and signed by me January 5, 2024 showing any monthly monetary received, does not substantiate my daily living needs **in addition to**, medical health necessary supplies/equipment, food, personal hygiene and home care product costs and etc.; the financial statement that was provided to the US Supreme Court shows our monthly budget was already in the **Negative**. And to date, that **Negative** amount remains and has **significantly** increased due to, over inflated utility rates, gas rates, and overall merchant prices. **(5)** Because we have continued fallen further behind the Financial realm of basic living stability and necessities, I am currently seeking further Social




Services assistance in order to maintain a weeks' worth of food due to the extreme cost of food inflation; and the medical fact that **because I am a diabetic**, my special food costs/expenses are much more in price and is currently impossible for me to even acquire a weeks' worth of the special foods I need and require and am able to safely consume in accordance to, my medical doctors and my medical specialists in addition to, the medical advice of my Gastrologist and surgeon.

Therefore, due to the reasons stated above/on page 1 of this motion, I respectfully asked the US Supreme Court to please reconsider the Motion for Reconsideration to Proceed *in forma pauperis* (without payment) and to also **Grant** this Motion to me.
