FOURTEENTH AMENDMENT, SECTION 1:

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

That, throughout the history of modern politics three global orders left a definite and lasting impact on the international community of the world. Each global order conquered a vast territorial domain and established a controlling element over a wide variety of different peoples and nations. Each global order contributed significantly to the advancement of the Earth's surface and the betterment of Mankind; however, were powerless to advance the world into its final developmental period.

To advance the world into its final developmental period we, the people, must relearn the 3,000-year history of the international community, which is divided into four periods of development: 1). The Origin of the international community 2). The Colonial Expansion of the international community 3). The Colonial (or Industrial) Revolution period and 4). The Establishment of the World's First Global Democracy – www.iglesianicristo.net.

The first developmental period of modern politics (US Copyright) was the longest in world history as the Roman Empire established the origin of the international community around the Mediterranean Sea from the 8th century BC to the 15th century AD. The nation of Rome formed the political foundation of the world as the former city-state body of politic was transformed into an expanding, dynamic and constantly changing international community under One government. After **THE FALL OF ROME**, the international community was divided into two political halves as the Eastern Roman Empire and the former Western provinces of Rome established a controlling element over their individual territorial domains.

From the 15th to 20th centuries AD the nations of Western Europe extended the borders of the international community from the Mediterranean to the outer confines of the earth. The European state system replaced the Roman Empire as the most powerful force in the world as the Eastern Roman (or Byzantine) Empire was defeated in war by the Ottoman Turks. The Western European *“continent”* was the political power center of the world as the Holy Roman Empire of Germany, Great Britain, France, Spain, Portugal, and the Netherlands established vast colonial empires on the surface of the Planet Earth.

In the last three centuries of the Second Millennium to date modern politics advanced to levels unprecedented in world history as the Colonial Expansion and Colonial Revolution periods converged in the international community. STATEMENT OF THE CASE

I pushed forward with what I've held on to for the whole of my life, bringing these charges against the DEFENDANT due to the hostile nature of A CAUSE LEFT UNRESOLVED. (See TRUE VERSION OF THE PHILIPPINE REVOLUTION, by Emilio Aguinaldo, First President & Commander-in-Chief of the Philippines) That, I too, directly experienced the injustice of the Philippine Revolutionary war, as these terrible violations of human rights perpetuated the entire last century of the Second Millennium to date. The true nature of this conflict was not revealed to the people of the world, as I carried these life altering, damaging and debilitating feelings for the whole of my life.

In the third generation following this injustice my Father immigrated to the United States of America. "The notion that, as time elapses, social, political and economic differences between immigrants and natives fade...¹⁰" But they didn't as my relationship with him was filled with so much hatred and anger that I vowed to do something about it. As a boy, with tears streaming down my face clenched fists and fervent ambition I would one day understand how this man, one of the most successful Physicians in the community could

treat me so badly. A realization of such magnitude did not come without obstacles. In my eighteenth year I attempted to take my own life by driving a car into a tree, as the negative forces which came from the barbaric annihilation of half the population of the Philippines during the third developmental period of modern politics made my head spin. (See *The Case to Establish God's True Nation on Earth: Unto the final developmental period, Case No. 22-11680*) Like a deadly virus out of control this injustice was brought forward with such devastating impact, which I didn't understand at the time but caused me tremendous grief.

I managed to finish a college education, but things never seemed right. I worked a variety of different jobs including in HRI&M (college degree) but I was always preoccupied with something else. Things didn't seem right and it showed. Why was I unhappy? What was wrong with my life? A life that seemed normal, but in an odd way it wasn't. At the age of 33 I realized the only way I'd understand what was wrong was to return to the Philippines, whereby, I published THE CASE OF THE PHILIPPINE PRIDE – a detailed, truthful and legalized account of the Philippine

Are the DEFENDANT and his Administration of the United States government a root cause of this injustice in the international community? Did former US President & Commander-in-Chief William McKinley intend to commit these barbaric acts, as his duty to his nation was stronger than his own ethical values? Is the DEFENDANT at fault that I became a victim, too, who couldn't cope with the tremendous guilt that befell the Filipino in the international community? What right do I have to justify said violations of human rights in the international community? What right do I have to justify said violations of human rights on the surface of the Planet Earth? What right do I have to justify said violations of human rights within the existing global order? (See Nobody Wants the Current World Order, By Shivshankar Menon, August 3, 2022) Violations that didn't directly have any impact on me, but due to its lasting negative impact, which continued to perpetuate in the international community, I couldn't bare to live.

Former US President & Commander-in-Chief William McKinley covered-up this injustice by initiating a policy called neocolonialism. A policy the succeeding twenty-one US Presidential Administrations have, subsequently inherited. A force I have been drawn to since I was a child. A truth that needs to be known as the first US President & Commander-in-Chief George Washington severed ties with his oppressor and formed an Independent and sovereign nation in the international community of the world.

From the Administration of Presidents Washington to McKinley to Biden each person whose filled that HIGH POST must be held accountable for the actions of the last as the existing global order (or American state system) unjustly established a controlling element over the territory of the Philippines in the international community of the world.

“forget” what they stood for? How could they do such a savage and barbaric thing?

In September 1901 former US President William McKinley was assassinated in the international community. It was the duty of the succeeding twenty-one US Presidents to adhere to the truth. Each one, however, invariably put this injustice behind them. The injustice of the Philippine Revolutionary war was thought never to be realized but the laws of nature and of nature’s God are more powerful, more omnipotent than that of Mankind¹².
