MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Petitioners Steven Antonius, AKA Sealed Defendant 1, and Argemiro Zapata-Castro, AKA Sealed Defendant 1, respectfully request leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.

On November 30, 2018, the United States District Court for the Southern District of New York found Petitioner Antonius indigent and appointed Jill R. Shellow, Esquire, counsel of record before this Court, pursuant to the Criminal Justice Act of 1964, as amended, 18 U.S.C. § 3006A (“CJA”). *See United States v. Gonzalez, et al.*, No. 18-CR-601 (PGG), Minute Entry, Nov. 30, 2018. Pursuant to the Second Circuit Court of Appeals Local Rule 4.1(a), Ms. Shellow’s CJA appointment was

continued for prosecuting Mr. Antonius' appeal in the Court of Appeals.

See also Fed. R. App 24(a)(3); United States Court of Appeals for the Second Circuit Criminal Justice Act Plan, Sec. III(A) (Mar. 9, 2022).

On November 30, 2018, the United States District Court for the Southern District of New York found Petitioner Zapata Castro indigent and appointed counsel pursuant to the CJA. *See United States v. Gonzalez, et al.*, No. 18 CR 601 (PGG), Minute Entry, Nov. 30, 2018. On October 15, 2021, the Second Circuit Court of Appeals appointed Peter J. Tomao, Esquire as successor CJA counsel for Mr. Zapata Castro to prosecute Mr. Zapata-Castro's appeal in the Court of Appeals. A copy of the Notice of Appointment of CJA Counsel and Order of the Court of Appeals are attached.

WHEREFORE, Petitioners move this Court for leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.
