## STATEMENT OF THE CASE

I, GREGORY C. Stockman, AM FILING this WRIT OF CERTIORARI IN PRO PER AND CANNOT AFFORD LEGAL help IN ORDER TO CONSTRUCT the proper, CORRECT sequel FOR FILING the WRIT OF CERTIORARI IN the legal Request FOR UNCONDITIONAL Release FROM Napa State Hospital. Deprivation of life, liberty AND property without due process. I WILL NOT sign A FRAUDULENT CONREP CONTRACT of A SVP that CLASSIFIED me as a Sexual Violent Predator.

I, GREGORY C. Stockman, am being INCARCERATED AT Napa State Hospital not because I am showing my MENTAL ILLNESS (BI-POLAR) because I ASKED my Conditional Release Program Agent, ERNIE HERNANDEZ for permission to REFINANCE my primary Residence, (831 Howard ST. SANTA ROSA, CA 95404) HOWEVER He did NOT inform me that I could NOT do so. IN COURT, MR. HERNANDEZ AND his CONREP manager, DR. CHRISTINA BARRASH told the COURT that MR. Stockman could NOT REFINANCE his home AND that he did it anyway. (17 yrs ago.)

These 17 years ago have destroyed my Quality of life, my physical Health, and my past and current Financial welfare, and wellbeing. Everything that I have was taken from me; which that I have worked for during my lifetime. I cannot sign a CONREP CONTRACT that says that I must take a Poly-graph Test because of my alleged Past Sexual Deviant Behavior. This 13 page contract has kept me at Napa State Hospital for over 7 years. I was released on October 6th, 2017 into the Sonoma County Conrep. I will NOT sign a PRIVILEGE CONREP CONTRACT that would have removed my support of my daughter, Lauren, 2 Grandchildren, Taelyn, 8 years, Tenney, 3 yr. old and my loyal friend who has been there for me for 30 years.

Please help me so I can lead a successful productive life! Thank you for your consideration.

## REASONS FOR GRANTING THE PETITION

I, GREGORY C. STOCKMAN, HAVE NOT HAD ANY PSYCHOTIC BREAKDOWNS SINCE APRIL 1993, AND THIS HAS BEEN DOCUMENTED IN A COURT OF LAW BY JUDGE SIMONDS ON OCTOBER 6TH 2017. HOWEVER, THE JUDGE DID NOT READ THE (CONREP) THE 13 PAGE TERMS AND CONDITIONS OF RELEASE PROGRAMS TERMS IN OPEN COURT, AS IT IS A USUAL PROCEDURE. IF JUDGE SIMONDS HAD READ THE CONREP CONTRACT, SHE WOULD HAVE REALIZED THAT IT WAS NOT REFERRING TO MY 10216 COMMITMENT, BUT INSTEAD IT WAS AN SVP (SEXUAL VIOLENT PREDATOR) CONTRACT. JUDGE SIMONDS HAD STATED IN OPEN COURT THAT SHE WAS ONLY GOING TO RELEASE ME IN SONOMA COUNTY CONREP BECAUSE I HAD SOCIAL CONTRACTS THAT WERE THERE (SANTA ROSA) AND ARE HELPFUL RESOURCES. SONOMA COUNTY CONREP MANAGER, DR. KATHIE MESSEROLI HAD REFUSED TO CHANGE THE TERMS AND CONDITIONS OF THE 13 PAGE CONTRACT.

I AM 76 YEARS OLD (07/07/1947) WITH NUMEROUS MEDICAL ISSUES SOME SURGERIES COMPLETED AND SOME PROCEDURES AND SURGERIES THAT DIDN'T WORK OUT AND HAVE TO BE DONE OVER. THESE CAN BE DONE IN THE COMMUNITY. I AM ALSO STUCK/CANNOT LEAVE FOR ANY REASONS BY Q3 & Q4 UNITS FOR OVER 3 YEARS. I HAVE NOT BEEN ABLE TO MEET MY MEDICAL NEEDS WHICH ARE VERY SERIOUS. I HAVE FILLED OUT GENERAL REQUESTS TO MY TREATMENT TEAM WITH NO RESPONSE AND ACTION.
