PETITION FOR REHEARING

Cody Dillon Hogan comes before this Honorable Court pro se and petitions the Court via rehearing for an Order Granting him certiorari, Vacating his conviction, and Remanding his case to the lower court for further proceedings in light of this Court's holding in United States v. Hansen, 143 S. Ct. 1932 (2023). Hogan was unaware of Hansen when filing for certiorari. Hansen was decided during the course of Hogan's appeal, and after counsel submitted her Anders brief. Hansen is directly on point to Hogan's case. Hansen defined the ordinary meaning of "induce" and offered guidance as to determining where Congress intends an ordinary meaning or an artful one. Without the benefit of considering this Court's decision in Hansen, the lower court used an overbroad interpretation of "induce" based on United States v. Murrell, 638 F.3d 1283 (11th Cir. 2004) when denying Hogan's appeal. Murrell explicitly rejects the ordinary meaning of "induce" stated in Hansen, and the ordinary meaning of "induce" is the definitive issue upholding Hogan's conviction. Hogan respectfully asserts that his conviction is constitutionally infirm based upon the holding in Hansen. Hogan believes that, upon remand, the lower court, given the opportunity for further consideration in light of Hansen, will overturn.

Thus, Hogan posits that a GVR order is appropriate.
