





As I was trying to finish up scanning the groceries for my customers in front of me and they were asking me if I was ok and asked the member of management why she did that and she just ran off and ignored me and my customers. I was then told that I was fired so I clocked out and left the building. I haven't been back to the Wausau Wal Mart since that day.
