

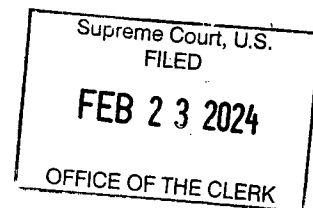

### QUESTION(S) PRESENTED

I was previously an inmate at Fort Bend County Jail, in Richmond, TX. The Medical Lieutenant Deputy Sheriff Scott Adams sexually assaulted me.

He grabbed me on my buttocks, between my legs, not in an accidental way, the way it happened was like that of a cobra, NOT FRIENDLY. He is employed by Fort Bend County Jail, but also, he presented his C.I.A. badge to me. He threatened to rape and drug me. He also threatened to kill me, if I "snitch," on him. Lower civil courts have dismissed my claim as frivolous. He won his grand jury indictment, (Ridiculous).

Do you believe in RIGHTS for sexual assault victims? Even when the police are the assailants?
