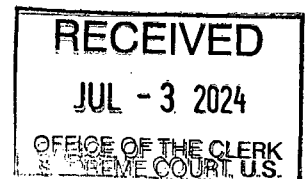

Prisoner by way of Bill Of Attainder/Pains and Penalties,

Petitioner respectfully requests that this Court grant rehearing of its order dated June 10, 2024, (*) which denied forma pauperis, and dismissed the petition for writ of certiorari under Rule 39.8.

The petition is a true criminal case filed below under 28 U.S.C. §§1455, 2241, 2255, State of Louisiana vs. Charles K. Wallace, axiomatically removed to the U.S. District Court, Eastern District of Louisiana, yet to be processed therein/ thereby waiving original jurisdiction to this Court.


The statute of limitation for trial therein is expired under law, having never waived petitioners' right to trial by jury therein, this case is never frivolous or malicious and this Honorable Court is under duty by Oath of Office to address the claim of denial of the right to trial by jury on removal, a substantive structural defect where the right to trial by jury is absent under the State Constitution and statutes in criminal law of this state at the point of the axiomatic removal. State divested jurisdiction by attainder.

Petitioner states that he has an unenumerated right to forma pauperis under the U.S. Constitution, Amendment IX, as a veteran of the United States .

Petitioner further states he has a Supreme Law of the Land right to this effective remedy by way of United States Constitution, Article VI, par. 2 in conjunction thereby United Nations, Universal Declaration of Human Rights, Articles 8, 9, 10, 11(1)-(2), 12, 13(1)-(2) and 14(1), as a political prisoner, by acts conforming to the purposes and principles of the United Nations under the Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made; The judicial Power of the United States shall extend to all Cases, ...and Treaties made, ...

For the reasons set forth in this petition for rehearing as well as the petition for forma pauperis and certiorari previously filed, forma pauperis and certiorari should now be granted.


